| <b>HB 611</b>  | <b>FAUCHEUX</b>       | <b>HOUSING/AUTHORITIES:</b> Provides relative to the appointment and removal of commissioners of parish housing authorities by the parish governing authority  |
| <b>HB 1043</b> | <b>FAUCHEUX</b>       | <b>CULTURE/REC/TOUR:</b> Creates the Manchac Parkway and the Manchac Parkway Commission  |
| <b>HB 1271</b> | <b>L JACKSON</b>      | <b>CIVIL SERVICE/FIRE &amp; POL:</b> Provides relative to formal training required of each person selected for appointment to the entry level position of Fire Communications Officer (I) in the city of Shreveport  |
| <b>HB 1452</b> | <b>HOPKINS</b>        | <b>DISTRICTS/FIRE PROTECT:</b> Provides relative to municipal annexation of territory included within fire protection districts in Caddo Parish  |
| <b>HB 1520</b> | <b>FAUCHEUX</b>       | <b>DISTRICTS/SPECIAL:</b> Creates a special taxing district in St. John the Baptist Parish and authorizes the district to levy a tax on certain slot machine proceeds and transfer certain proceeds of the tax to the state  |
| <b>HB 1591</b> | <b>McDONALD</b>       | <b>DISTRICTS/DOWNTOWNDEVEL:</b> Creates the Bastrop Downtown Development District  |
| <b>HB 1757</b> | <b>WALSWORTH</b>      | <b>DISTRICTS/ECONOMIC DEVEL:</b> Creates the Southwest Ouachita Economic Development District  |
| <b>HB 1809</b> | <b>THOMPSON (TBA)</b> | <b>CULTURE/REC/TOUR:</b> Prohibits personal watercraft (jet ski) operation on any body of water managed by or surrounded by land owned by the office of state parks; authorizes rules regulating recreational use of such water bodies <b>(Subject to Rule Suspension)</b> |
| <b>HB 1859</b> | <b>WOOTON</b>         | <b>MUNICIPALITIES:</b> Increases the sum of money that parish governing authorities are authorized to appropriate annually for fairs, agricultural festivals, and other agricultural events  |
| <b>HB 1892</b> | <b>WALSWORTH</b>      | <b>CIVIL SERVICE/FIRE &amp; POL:</b> Removes requirement that an applicant admitted to certain tests for employment in the fire or police civil service in certain municipalities shall be a qualified elector of the state  |
| <b>HB 1943</b> | <b>LEBLANC</b>        | <b>DISTRICTS/PUBLIC IMPROVE:</b> Creates the Lafayette Metropolitan Expressway Commission  |
| <b>HB 1945</b> | <b>DIEZ (TBA)</b>     | <b>HIGHWAYS:</b> Changes the name of the Louisiana Scenic Byways Programs and creates a Louisiana Byways Commission within the Department of Culture, Recreation and Tourism <b>(Subject to Rule Suspension)</b>   |
| <b>HB 1969</b> | <b>SCHWEGMANN</b>     | <b>DISTRICTS/TAXING:</b> Provides for the continuation of certain taxes and fees levied by improvement districts   |

<b>SB 260</b>	<b>ELLINGTON</b>	<b>SPECIAL DISTRICTS:</b> Provides for revisions to the LaSalle Economic Development District.
<b>SB 800</b>	<b>BAJOIE</b>	<b>IMMOVABLE PROPERTY:</b> Provides for redemptive period affecting post-adjudication donation of abandoned or blighted property by parishes and municipalities. (gov sig)
<b>SB 830</b>	<b>BAJOIE</b>	<b>IMMOVABLE PROPERTY:</b> Authorizes municipalities and parishes to sell certain adjudicated vacant lots by private sale. (gov sig)
<b>SB 846</b>	<b>ELLINGTON</b>	<b>SPECIAL DISTRICTS:</b> Creates a downtown development district in the town of Columbia. (gov sig)
<b>SB 847</b>	<b>ELLINGTON</b>	<b>SPECIAL DISTRICTS:</b> Creates a downtown development district in the town of Winnsboro. (gov sig)
<b>SB 902</b>	<b>BAJOIE</b>	<b>IMMOVABLE PROPERTY:</b> Authorizes municipalities and parishes to sell certain adjudicated vacant lots by public or private sale. (gov sig)
