| <b>SB 245</b> | <b>MICHOT</b>        | <b>TAX/LOCAL</b> Authorize certain parishes to increase their sales tax by one percent. (7/1/06)  |
| <b>SB 468</b> | <b>SCHEDLER</b>      | <b>HOSPITALS</b> Provides relative to the contracting authority of the boards of St. Tammany Parish Hospital Service District No. 1 and St. Tammany Parish Hospital Service District No. 2. |
| <b>SB 469</b> | <b>SCHEDLER</b>      | <b>SPECIAL DISTRICTS</b> Renames the East St. Tammany Events Center District to the Northshore Harbor Center District and provides for certain changes.                                     |
| <b>SB 601</b> | <b>GAUTREAUX, N.</b> | <b>MUSEUMS</b> Establishes the La. Military Hall of Fame and Museum as a facility in Abbeville under the jurisdiction of the Dept. of State.  |
| <b>SB 640</b> | <b>DUPLESSIS</b>     | <b>PUBLIC PROPERTY</b> Authorizes political subdivisions to sell surplus movable property on the Internet.  |
| <b>SB 658</b> | <b>ROMERO, C.</b>    | <b>CIVIL SERVICE</b> Provides for continuance of certain municipal fire and police civil service systems under certain circumstances. (gov sig) (2/3-CAXs18)                                |
| <b>SB 663</b> | <b>GAUTREAUX, N.</b> | <b>LIBRARIES</b> Provides for the board membership of the Vermilion Parish Library Board of Control and authorizes the board to administer and account for library funds. (1/1/07)          |
| <b>SB 684</b> | <b>DUPLESSIS</b>     | <b>SPECIAL DISTRICTS</b> Provides with respect to the board membership and authority of the New Orleans Regional Business Park. (gov sig)   |
| <b>SB 699</b> | <b>BAJOIE</b>        | <b>PUBLIC BUILDINGS/GROUNDS</b> Extends the existence of the Rev. Avery C. Alexander Memorial Commission. (gov sig)   |
| <b>SB 709</b> | <b>MURRAY</b>        | <b>LOCAL AGENCIES</b> Provides for additional commissioners for, and preparation and implementation of community improvement plans by, the New Orleans Redevelopment Authority. (gov sig)   |
