| <b>HB 1096</b> | <b>LAFLEUR</b>  | <b>CLERKS OF COURT</b> Provides that a clerk of court who has served as a clerk of court for a specified time period shall be deemed certified for certain purposes          |
| <b>HB 1191</b> | <b>THOMPSON</b> | <b>HOMELAND SECURITY</b> Provides relative to the duties and responsibilities of the Governor's Office of Homeland Security and Emergency Preparedness and parish presidents |
| <b>HB 1274</b> | <b>TOOMY</b>    | <b>HOLIDAYS</b> Authorizes a clerk of a district, parish, and city court to close his office on any day an emergency has been declared                                       |
| <b>HB 1275</b> | <b>TOOMY</b>    | <b>CLERKS OF COURT</b> Reimburses the clerk of court for all postage costs incurred related to appearance bonds  |
