HB 132	BURNS	ABORTION Criminalizes the act of performing an abortion
HB 1264	SCALISE	CRIME Criminalizes partial birth abortion
SB 33	NEVERS	ABORTION Prohibits abortion, except when necessary to save the life of the mother.
SB 129	JONES	CRIMINAL JUSTICE Modifies the rate at which good time can be earned from 30 days for every 30 days served to 35 days for every 30 days served for eligible offenders and to three days for every 17 served for inmates convicted of rape of a victim under 13, aggravated incest, or molestation of a juvenile.

HB 14	CROWE	GAMBLING Requires notice of addictive nature of gaming and gaming hotline information in all forms of advertisement of gaming activities
HB 522	FARRAR	CRIMINAL/BAIL Provides for the abandonment of enforcement and collection of judgments involving a bond forfeiture
HB 526	FARRAR	CRIMINAL/BAIL Provides for the qualifications of personal sureties in bail undertakings
HB 527	MARTINY	CRIMINAL/PROCEDURE Provides for the delays for forfeiture and collection of appearance bonds
HB 573	BALDONE	BONDS/BAIL Provides with respect to procedures for bond forfeiture
HB 682	CARTER, K.	GAMBLING/CASINO Provides relative to the execution of the casino support services contracts and requires legislative appropriation to fully fund the contract
HB 784	MARTINY	BONDS/BAIL Provides with respect to bail bond contracts during times of emergency or disaster
HB 1113	BALDONE	CRIME/SEX OFFENSES Amends definition of sex offender
HB 1192	THOMPSON	PARDON/PAROLE Creates a pilot special needs parole program within the Department of Public Safety and Corrections

HB 1290	WOOTON	CORRECTIONS Provides with respect to housing inmates pending competency hearings
SB 47	NEVERS	MOTOR VEHICLES Creates and provides for the DWI license plate. (2/3-CA7s2.1(A))
SB 566	CHAISSON	CRIMINAL PROCEDURE Provides with respect to bail bond contracts during times of emergency or disaster. (gov sig)
SB 611	ADLEY	VIDEO POKER Requires public notice prior to application for truck stop gaming license.
