<b>HB42</b>	<b>STRAIN</b>	<b>TAX/GIFT TAX</b> Repeals the gift tax
<b>HB43</b>	<b>TOWNSEND</b>	<b>TAX/INHERITANCE TAX</b> Deletes requirement that successions be opened within nine months for inheritance tax to be waived
<b>HB53</b>	<b>GREENE</b>	<b>TAX/GIFT TAX</b> Repeals the gift tax
<b>HB115</b>	<b>LAFLEUR</b>	<b>TAX/GIFT TAX</b> Repeals the gift tax
<b>HB117</b>	<b>MONTGOMERY</b>	<b>TAX/GASOLINE TAX</b> Provides for an exemption for gasoline used in the manufacture of certain premixed two-cycle engine fuel containing gasoline and oil
<b>HB159</b>	<b>MORRISH</b>	<b>TAX/VEHICLE REGISTRATION</b> Continues additional tax on boat trailers to fund aquatic weed control programs
<b>HB163</b>	<b>TOWNSEND</b>	<b>TAX/GASOLINE TAX</b> Provides for a gasoline and special fuels tax credit for volunteer fire departments
<b>HB200</b>	<b>SALTER</b>	<b>ASSESSORS</b> Increases expense allowance for assessor of Red River Parish
<b>HB211</b>	<b>ST. GERMAIN</b>	<b>ASSESSORS</b> Provides for the payment of certain insurance premium costs for certain retired assessors and assessor's employees in certain parishes
<b>HB240</b>	<b>TOWNSEND</b>	<b>TAX/SALES &amp; USE</b> Provides for a sales and use tax exemption for certain trucks and trailers
<b>HB259</b>	<b>TOOMY</b>	<b>TAX/INCOME-INDIV/CREDIT</b> Provides for an individual income tax credit for certain volunteer firefighters
<b>HB335</b>	<b>LAFLEUR</b>	<b>TAX/AD VALOREM TAX</b> Repeals the annual fee for notice of ad valorem tax delinquency to

		mortgagees and authorizes a new one-time fee for notice of ad valorem tax delinquency
<b>HB367</b>	<b>TOWNSEND</b>	<b>TAX/INCOME-INDIV/EXEMPT</b> Provides for an individual income tax exclusion for state income tax refunds
<b>HB368</b>	<b>TOWNSEND</b>	<b>TAX/INCOME-INDIV/EXEMPT</b> Provides for an individual income tax exclusion for monies received from the Louisiana Recovery Authority
<b>HB372</b>	<b>TOWNSEND</b>	<b>TAX CREDITS</b> Provides for a refundable enterprise zone income tax investment tax credit
<b>HB405</b>	<b>GUILLORY, MICKEY</b>	<b>TAX/TOBACCO TAX</b> Provides relative to the discount for timely filing and payment of the tobacco tax and cigarette state tax
<b>HB417</b>	<b>FAUCHEUX</b>	<b>TAX/GASOLINE TAX</b> Provides for refunds of taxes paid on blend stocks or feed stocks when used to produce non-motor fuel products
<b>HB467</b>	<b>TOWNSEND</b>	<b>ASSESSORS</b> Increases the compensation of assessors
<b>HB482</b>	<b>GREENE</b>	<b>TAX RETURN</b> Allows for donation to Legacy Donor Foundation on income tax return
<b>HB529</b>	<b>LORUSSO</b>	<b>TAX/GIFT TAX</b> Repeals the gift tax
<b>HB546</b>	<b>ROBIDEAUX</b>	<b>TAX/INCOME-INDIV/CREDIT</b> Provides for an individual income tax credit for election commissioners
<b>HB608</b>	<b>THOMPSON</b>	<b>TAX/GIFT TAX</b> Repeals the gift tax
<b>HB633</b>	<b>TOWNSEND</b>	<b>TAX/SALES &amp; USE</b> Provides for the immediate, full phase-in of the reduction in taxes for motor vehicle manufacturers
<b>HB665</b>	<b>TOWNSEND</b>	<b>TAX/GIFT TAX</b> Repeal gift tax
<b>HB688</b>	<b>TOWNSEND</b>	<b>TAX/INCOME-INDIV/CREDIT</b> Provides for an individual income tax credit for election commissioners
<b>HB689</b>	<b>TOWNSEND</b>	<b>TAX/INCOME-INDIV/CREDIT</b> Provides for an individual income tax credit for certain volunteer firefighters
