| HCR 47 | WHITE | TRANSPORTATION DEPT Directs the Department of Transportation and Development to install a traffic light at the intersection of La. Hwy. 16 and Cecil Drive |
| HCR 55 | BADON | TRANSPORTATION DEPT Expresses dissatisfaction with the Department of Transportation and Development's efforts in Orleans Parish |
| HCR 72 | HUTTER | WATERWAYS Directs the U.S. Army Corps of Engineers to immediately close the Mississippi River Gulf Outlet |
| HB 99 | CROWE | MTR VEHICLE/VIOLATIONS Prohibits the use of a cellular telephone while operating a motor vehicle in a school zone during posted hours |
| HB 315 | LAFLEUR | MTR VEHICLE/LICEN PLATES Creates the "Chez nous autres" prestige license plate |
| HB 407 | CARTER, K. | MTR VEHICLE/DRIVER LIC Extends the sunset date of an extra fee on drivers' licenses used to fund litter reduction efforts |
| HB 413 | TUCKER | LEVEES/BDS & DISTRICTS Provides relative to the Southeast Louisiana Flood Protection Authority-West Bank |
| HB 511 | ST. GERMAIN | RAILROADS Prohibits closure of railroad grade crossings when closure would prevent rights of passage in effect for 20 years |

HB 628	CARTER, K. (TBA)	LEVEES Clarifies and provides for the ownership and management of certain property of the Orleans Levee District (Subject to Rule Suspension)
HB 766	FANNIN	MTR VEHICLE/DRIVER LIC Provides relative to the eligibility of foreign nationals for driver's licenses
HB 778	PITRE	TRANSPORTATION Facilitates the imposition and collection of tolls by video or photo-monitoring on Louisiana Highway 1
HB 781	POWELL, M.	PUBLIC CONTRACT/BIDS Requires certain successful bidders to provide notarized declarations of certain information
HB 897	KENNARD (TBA)	MTR VEHICLE/DRIVER LIC Requires disqualification of commercial driving privileges for certain offenses (Subject to Rule Suspension)
HB 932	TUCKER	LEVEES/BDS & DISTRICTS Provides relative to flood protection in Orleans Parish on the west side of the Mississippi River
