HB 11	HARDY	SEIZURES/SALES Provides for an increase in the amount of the homestead exemption from seizure and sale
HB 217	FOIL	HEALTH CARE/RECORDS Provides relative to fees paid for copying medical records
HB 288	LITTLE	COURTS/COURT COSTS Requires the nonprevailing party to pay court costs if the suit or the defense to the suit is frivolous
HB 372	CHANDLER	SEIZURES/SALES Increases the state bankruptcy exemption on homes
HB 374	CHANDLER (TBA)	CHILDREN/CUSTODY Provides for the qualifications of child custody mediators (Subject to Rule Suspension)
HB 568	LAFONTA	COMMERCE Authorizes class action lawsuits for unfair trade practices
HB 633	ANDERS	LIABILITY/CIVIL Provides a limitation of liability for certain agritourism activities
HB 740	LIGI (TBA)	RETIREMENT BENEFITS (Constitutional Amendment) Provides for forfeiture of public retirement benefits by certain persons who are convicted of felony acts associated with their positions (Subject to Rule Suspension) (<i>Technical Review Only</i>)
HB 781	WADDELL	NOTARIES Provides for unlawful exercise of notary powers

HB 783	CONNICK (TBA)	RETIREMENT BENEFITS (Constitutional Amendment) Authorizes the forfeiture of certain school employee-related retirement benefits for those found guilty of a sex crime against a student (Subject to Rule Suspension) <i>(Technical Review Only)</i>
HB 835	GEYMANN (TBA)	BUDGETARY CONTROLS (Constitutional Amendment) Disposition of state general fund monies in excess of the expenditure limit (Subject to Rule Suspension) <i>(Technical Review Only)</i>
HB 837	MARCHAND	LEASES Provides for certain rights and obligations of lessors and lessees relative to residential leases
HB 895	GREENE	HEALTH CARE/RECORDS Provides relative to certification of completeness of health care records
HB 986	ABRAMSON	PRESCRIPTION Provides for the prescriptive period for judgments, liens, and privileges against the state, its agencies, and political subdivisions thereof
HB 1085	PUGH	FINANCIAL PLANNING Provides for the transfer of certain investment securities upon death
HB 1202	GREENE (TBA)	CHILDREN/CUSTODY Provides for the relocation of children (Subject to Rule Suspension)
