| <b>HCR 153</b> | <b>DIXON</b>           | <b>TEACHERS</b> Requests the High School Redesign Commission to consider and make recommendations relative to certain in-service training for teachers and other staff  |
| <b>HCR 160</b> | <b>LEGER (TBA)</b>     | <b>STUDENTS</b> Requests BESE to study the issue of harassment, intimidation, and bullying of students and to report written findings to the House and Senate education committees at least 60 days prior to the beginning of 2009 R.S. <b>(Subject to rule suspension)</b> |
| <b>HCR 168</b> | <b>TRAHAN (TBA)</b>    | <b>EDUCATION/PRE-K</b> Requests BESE to study collaboration among early childhood education programs <b>(Subject to rule suspension)</b>  |
| <b>HCR 170</b> | <b>MORRELL (TBA)</b>   | <b>STUDENT/ASSESSMENT</b> Requests BESE to study giving equal weight to science and social studies in administering the LEAP tests <b>(Subject to rule suspension)</b>  |
| <b>SB 268</b>  | <b>DUPLESSIS</b>       | <b>BESE</b> Prohibits renewal of the charter of a failing school unless the school meets certain criteria. (8/15/08)  |
| <b>SB 269</b>  | <b>MCPHERSON</b>       | <b>HEALTH CARE</b> Reorganizes the Louisiana Health Works Commission. (8/15/08)   |
| <b>SB 286</b>  | <b>DUPLESSIS (TBA)</b> | <b>EARLY CHILDHOOD ED</b> Provides for phased in universal access to the LA 4 Early Childhood Program and for participation by non-school system providers of early childhood education. (8/15/08) <b>(Subject to rule suspension)</b>                                      |
| <b>SCR 42</b>  | <b>NEVERS (TBA)</b>    | <b>COLLEGES/UNIVERSITIES</b> Approves the establishment of a learning center in St. Tammany Parish. <b>(Subject to rule suspension)</b>   |
