| <b>HB 987</b>  | <b>GALLOT</b>      | <b>ELECTION CODE</b> Provides relative to evidence of disability to be presented by a voter in order for him to be entitled to assistance in voting   |
| <b>HB 1016</b> | <b>SMILEY</b>      | <b>BOARDS/COMMISSIONS</b> Abolishes certain boards, commissions, authorities, and like entities   |
| <b>HB 1100</b> | <b>WADDELL</b>     | <b>PUBLIC RECORDS</b> Limits the public records law exemption for the office of the governor  |
| <b>HB 1108</b> | <b>BARROW</b>      | <b>PARISH/EAST BATON ROUGE</b> Provides relative to the East Baton Rouge Redevelopment Authority  |

<b>HB 1154</b>	<b>LEGER</b>	<b>LEGISLATIVE AUDITOR</b> Exempts certain groups from review by the legislative auditor
<b>HB 1181</b>	<b>LORUSSO</b>	<b>ETHICS/CODE</b> Excludes certain members of the National Guard from the definition of "public employee" for purposes of the Code of Governmental Ethics
<b>HB 1184</b>	<b>LEGER</b>	<b>HIGHER EDUCATION</b> Provides relative to certain entities that support public institutions of higher education
