| SB 2 | CHAISSON (TBA) | FUNDS/FUNDING Provides procedures relative to avoidance of budget deficits. (gov sig) (Subject to Rule Suspension) |
| SB 42 | MURRAY (TBA) | FUNDS/FUNDING Dedicates state funds for the purpose of providing for health insurance premiums of certain plan members on hurricane effected areas. (7/1/09) (Subject to Rule Suspension) |
