| HB 955 | LEGER (TBA) | HOUSING/AUTHORITIES Provides relative to the New Orleans Redevelopment Authority (Subject to Rule Suspension) |
| HB 1424 | BILLIOT | CIVIL SERVICE/FIRE & POL Provides that the classified fire service shall be applicable to nonprofit corporations that enter into cooperative endeavor agreements with certain municipalities, parishes, and fire protection districts |
| SB 141 | HEBERT (TBA) | LOCAL FINANCE Authorizes public entities utilizing tax increment finance ("TIF") to enter into a joint venture or cooperative endeavor with one or more other public entities utilizing TIF to utilize all or a portion of the tax increments generated within their TIF areas in order to jointly finance or refinance one or more economic development projects located within their TIF areas. (gov sig) (Subject to Rule Suspension) |
| SB 221 | APPEL (TBA) | COMMERCIAL REGULATIONS Prohibits a political subdivision from imposing a tax or fee on nonresidents at a different rate than residents. (Subject to Rule Suspension) |
| SB 356 | MORRELL | LOCAL AGENCIES Provides that the New Orleans Civil Service Commission shall hold its public meetings in the New Orleans City Council chambers. (8/15/10) |
| SB 357 | MORRELL | LOCAL AGENCIES Requires the New Orleans Civil Service Commission to give promotional exams to Fire Operators, Fire Captains, Fire District Chiefs and Fire Deputy Chiefs on an annual rotating basis. (8/15/10) |
| SB 559 | WALSWORTH | PARKS Provides relative to the membership of the State Parks and Recreation Commission. (8/15/10) |
| SB 646 | HEBERT | PUBLIC CONTRACTS Authorizes certain parishes to provide excavation equipment to parish residents for drainage maintenance and improvement. (1/1/11) |

- SB 651** **HEBERT** **AIRCRAFT/AVIATION** Provides relative to the adoption of airport zoning regulations ensuring compatible land use and aviation safety. (8/15/10)
- SB 699** **PETERSON (TBA)** **PUBLIC WORKS** Authorizes public entities to create public benefit corporations for financing arrangements regarding public property. (gov sig) **(Subject to Rule Suspension)**
- SB 747** **JACKSON, L. (TBA)** **FUNDS/FUNDING** Provides that applicants for Road Home grants who were denied because of unresolved succession/heirship issues be given a grant subject to a covenant restriction filed against the property. (gov sig) **(Subject to Rule Suspension)**
- SB 759** **THOMPSON** **SPECIAL DISTRICTS** Creates the Madison Parish Economic and Industrial Development District. (gov sig)
- SB 761** **DUPLESSIS** **SPECIAL DISTRICTS** Provides relative to the New Orleans Regional Business Park. (gov sig)
- SB 800** **LAFLEUR** **CODOFIL** Creates the Council for the Development of French in Louisiana. (8/15/10)
