HCR 175	SMITH, PATRICIA (TBA)	STATE EMPLOYEES Directs the commissioner of administration to study and make recommendations on reductions to state employment (Subject to Rule Suspension)
SCR 33	PETERSON	ADMINISTRATION DIVISION Directs the division of administration to publicly disclose the savings to be achieved by outsourcing services currently performed by state employees and the benefits that the contractor will be providing its employees prior to entering any contract outsourcing such services.
SB 1	CHAISSON	FUNDS/FUNDING Constitutional amendment to provide relative to deposits into and transfers out of the Budget Stabilization Fund. (2/3-CA13s1(A))
SB 2	CHAISSON	FUNDS/FUNDING Provides relative to deposits into and transfers out of the Budget Stabilization Fund. (See Act)
SB 367	MICHOT (TBA)	PROCUREMENT CODE Authorizes the use of reverse auctions by certain public entities. (7/1/10) (Subject to Rule Suspension)
SB 391	CHAISSON	FUNDS/FUNDING Constitutional amendment to authorize limited redirection and transfer of funds supporting appropriations and allocations from the state general fund and dedicated funds in certain circumstances. (2/3 CA13s1(A))
SB 392	CHAISSON	FUNDS/FUNDING Authorizes limited redirection and transfer of funds supporting appropriations and allocations from the state general fund and dedicated funds in certain circumstances. (See Act)
SB 401	THOMPSON (TBA)	HOSPITALS Provides relative to rural hospital reimbursement. (8/15/10) (Subject to Rule Suspension)
SB 410	CHAISSON	FUNDS/FUNDING Changes allocation of deposits into the Millennium Trust and the Louisiana Fund. (See Act)

SB 414	JACKSON, L.	FISCAL CONTROLS Requires certain information in the budget requests and the executive budget. (7/1/10)
SB 434	CHAISSON	FUNDS/FUNDING Constitutional amendment relative to deposits into the Millennium Trust and the Louisiana Fund. (2/3 CA13s1(A))
SB 509	LONG	SCHOOLS Includes the Louisiana School for Math, Science, and the Arts and the New Orleans Center for the Creative Arts in the MFP. (gov sig)
SB 563	CHEEK	NURSING HOMES Makes changes to the nursing home reimbursement methodology. (8/15/10)
SB 565	JACKSON, L.	FUNDS/FUNDING Provides relative to the purposes of certain collections in the city of Shreveport. (7/1/10)
SB 656	HEBERT	FISCAL CONTROLS Provides for certain state appropriation bills and political subdivisions' budgets to compare the previous year's funding level. (1/1/11)
SB 706	JACKSON, L.	FISCAL CONTROLS Provides for the Five Year Estimated Revenue Loss Chart from the Tax Exemption Budget to be an appendix to the General Appropriation Bill. (8/15/10)
SB 749	MURRAY	LEGISLATIVE AGENCIES Requires review by the Litigation Subcommittee of the Joint Legislative Committee on the Budget of certain negotiations, compromises and settlements. (7/1/10)
