

| HB 538 | BURFORD | TAX/HOTEL OCCUPANCY Authorizes the governing authority of the city of Mansfield to levy and collect a hotel occupancy tax subject to voter approval |
| HB 544 | PUGH | DISTRICTS/WATERWORKS Increases the amount of per diem paid to the members of the governing board of the Tangipahoa Water District |
| HB 781 | CHAMPAGNE | DISTRICTS/SPECIAL Creates a combined wastewater district for the towns of Erath and Delcambre |
| HB 849 | ROY | TAX/TAXATION Authorizes municipal tax collectors to employ private counsel or an agency for collection of delinquent taxes and provides for the collection of a fee for such services |
| HB 957 | LORUSSO | DISTRICTS/TAXING Creates the Lake Area Taxing District in Orleans Parish |
| HB 992 | BADON, AUSTIN | PROPERTY/ABANDONED Provides relative to abandoned and blighted housing property donated to or purchased by a nonprofit organization |
| HB 1032 | BARROW | DISTRICTS/ECONOMIC DEVEL Changes the membership of the board of commissioners of the Greenwell Springs-Airline Economic Development District |
| HB 1054 | NORTON | LIBRARIES Requires public libraries to have an African American section |
| HB 1080 | JONES, ROSALIND | MUNICIPALITIES Provides relative to the redevelopment of blighted property in the city of Monroe |
| HB 1104 | ROBIDEAUX | PARISH/LAFAYETTE Creates the Lafayette Parish Redevelopment Authority |
| HB 1215 | BARROW | DISTRICTS/SPECIAL Creates the Southern University Planning District in East Baton Rouge Parish |

HB 1287	LORUSSO	BOARDS/COMMISSIONS Creates the Battle of New Orleans Bicentennial Commission for the purpose of commemorating the 200th anniversary of the Battle of New Orleans
HB 1290	AUBERT	POLICE/MUNICIPAL Provides relative to the power of an elected police chief in certain municipalities to appoint, promote, discipline, and discharge police personnel
HB 1293	EDWARDS	POLICE/MUNICIPAL Provides relative to the power of an elected police chief in certain municipalities to appoint, promote, discipline, and discharge police personnel
HB 1297	WHITE (TBA)	CIVIL SERVICE/FIRE & POL Provides relative to the qualifications of certain members appointed to municipal fire and police civil service boards (Subject to Rule Suspension)
HB 1409	JACKSON, GIROD	HOUSING Provides relative to notices for demolition or removal of buildings
HB 1454	SMITH, PATRICIA	HOUSING Creates the Housing and Transportation Planning and Coordinating Commission
