| HR 13 | HARDY | COMMITTEE STUDIES Requests the House Committee on House and Governmental Affairs to review the issue of the redistricting of courts particularly as it relates to the domicile and residency requirements of judges and judicial candidates |
| HR 29 | HARRISON | HOUSE/RULES Allows the use of the supplemental vouchered allotment to supplement the salary of a legislative assistant |
| HCR 3 | FOIL | CONSTITUTION/CONVENTION Creates a commission to study the feasibility of a constitutional convention and makes recommendations relative thereto |
| HCR 51 | HARRISON | U.S. CONSTITUTION Claims state sovereignty for La. under the 10th Amendment to the U.S. Constitution and demands that the federal government cease promulgating unconstitutional mandates |
| HCR 128 | SCHRODER | STATE EMPLOYEES Requests establishment of pay systems and procedures for classified and unclassified state employees that provide for cost-of-living increases and rewards for performance and clearly distinguish between them |
| HB 73 | SMILEY | PUBLIC RECORDS Permits state agencies to store records electronically |
| HB 203 | GEYMANN | PUBLIC EMPLOYEES Requires legislative approval for a state executive branch official or employee to receive compensation that exceeds the salary authorized by law for the governor by more than 20% with certain exceptions |
| HB 376 | NOWLIN | PRINTING Authorizes the expenditure of public funds to promote online and Internet programs of public institutions of higher learning |
| HB 409 | LABRUZZO | REAPPORTIONMENT/HOUSE Provides for the districts for the election of members to the House of Representatives |

HB 428	GALLOT (TBA)	REAPPORTIONMENT/HOUSE Provides for the districts for the election of members of the Louisiana House of Representatives (Subject to Rule Suspension)
HB 432	HENRY (TBA)	REAPPORTIONMENT/HOUSE Provides for the districts for the election of members to the House of Representatives (Subject to Rule Suspension)
HB 433	NOWLIN	REAPPORTIONMENT/HOUSE Provides for the districts for the election of members to the House of Representatives
HB 496	BARROW	BOARDS/COMMISSIONS Provides for campaign contribution disclosures by appointees to certain boards and commissions prior to confirmation
HB 521	AUBERT	REAPPORTIONMENT/JUDGES Provides relative to the Court of Appeal, First Circuit
HB 523	JACKSON, GIROD (TBA)	JUDGES Provides relative to vacancies in the Twenty-Fourth Judicial District Court (Subject to Rule Suspension)
HB 525	BALDONE	REAPPORTIONMENT/CONGRESS Provides for the election districts for congress
HB 574	BALDONE	PUBLIC RECORDS Provides that certain criminal history records are public records and for accessibility thereto
