<b>HB 27</b>	<b>BROSSETT</b>	<b>TAX EXEMPTIONS/HOMESTEAD</b> Requires the assessor in Orleans Parish to provide property owners with a form for permanent registration of the homestead exemption
<b>HB 37</b>	<b>NOWLIN</b>	<b>TAX</b> Provides relative to the monthly transmission of certain tax collection information for local taxes
<b>HB 104</b>	<b>DOWNS</b>	<b>TAX COMMISSION, STATE</b> Provides relative to certain meetings of the La. Tax Commission
<b>HB 135</b>	<b>NOWLIN</b>	<b>TAX/PROPERTY TRANSFER</b> (Constitutional Amendment) Prohibits the levy of new taxes or fees upon the sale or transfer of immovable property for Nov. 30, 2011
<b>HB 207</b>	<b>JOHNSON</b>	<b>TAX/HOTEL OCCUPANCY</b> Authorizes certain municipalities, subject to voter approval, to levy and collect a hotel occupancy tax
<b>HB 209</b>	<b>ROBIDEAUX</b>	<b>REVENUE DEPARTMENT</b> Provides with respect to the use of managed and sampling audits of tax returns
<b>HB 281</b>	<b>ELLINGTON</b>	<b>ASSESSORS</b> Requires the assessor in certain parishes to pay insurance premiums for retirees
<b>HB 282</b>	<b>ELLINGTON (TBA)</b>	<b>TAX/SALES &amp; USE</b> Extends termination of the state sales and use tax exclusion for certain alternative substances used as fuel by manufacturers <b>(Subject to Rule Suspension)</b>
<b>HB 295</b>	<b>GREENE</b>	<b>TAX/PROPERTY TRANSFER</b> (Constitutional Amendment) Prohibits the levy of new taxes or fees upon the sale or transfer of immovable property after Nov. 30, 2011
<b>HB 348</b>	<b>LEGER</b>	<b>TAX CREDITS</b> Increases the amount of the tax credit for the rehabilitation of certain residential structures and extends the taxable periods in which the tax credit applies
<b>HB 349</b>	<b>LEGER</b>	<b>TAX CREDITS</b> Extends applicability of the tax credit for the rehabilitation of certain historic structures

<b>HB 370</b>	<b>SMITH, JANE</b>	<b>BONDS/STATE</b> Authorizes the State Bond Commission to issue bonds secured by unclaimed property monies for the completion of I-49
<b>HB 441</b>	<b>CARTER</b>	<b>TAX CREDITS</b> Extends the research and development tax credit program from Dec. 31, 2013, to Dec. 31, 2019, and changes the refundable tax credit to a tax rebate
<b>HB 455</b>	<b>HARRISON</b>	<b>REVENUE DEPARTMENT</b> Provides relative to the confidential character of tax records and the sharing of information regarding postsecondary education and employment information with the La. Board of Regents
<b>HB 458</b>	<b>HILL</b>	<b>TAX/INCOME-INDIV/RETURN</b> Creates an individual income tax return checkoff for donations to the La. Food Bank Association
<b>HB 466</b>	<b>DANAHAY</b>	<b>PROPERTY</b> Provides relative to the sale of adjudicated property in Calcasieu Parish
<b>HB 467</b>	<b>CARTER</b>	<b>TAX/TAX REBATES</b> Extends the Technology Commercialization and Jobs Tax Credit Program from Dec. 31, 2011, to Dec. 31, 2017, and converts it to a tax rebate
<b>HB 484</b>	<b>ABRAMSON</b>	<b>TAX/AD VALOREM-EXEMPTION</b> Provides for property tax exemptions for nonprofit entities in Orleans Parish and the city of New Orleans
<b>HB 486</b>	<b>GREENE</b>	<b>TAX/SALES-USE-EXEMPT</b> Clarifies that video-on-demand and pay-per-view services shall be exempt from state and local sales and use tax
<b>HB 550</b>	<b>JOHNSON</b>	<b>TAX RETURN</b> The Louisiana Make-A-Wish Act to provide an individual income tax return checkoff for donations to the Make-A-Wish Foundation
<b>HB 592</b>	<b>ST. GERMAIN</b>	<b>TAX EXEMPTIONS</b> Extends the period in which new applications for tax benefits pursuant to the Atchafalaya Trace Heritage Area Development Zone may be approved
