HB 327	ROY	DISTRICTS/ECONOMIC DEVEL Extends the boundaries of the Alexandria Central Economic Development District
HB 328	ROBIDEAUX	LIBRARIES Provides for an increase in fees collected for the Lafayette Parish Law Library Commission
HB 330	LITTLE	MUNICIPALITIES Provides relative to the powers and duties of the city of Bastrop with respect to expropriation of property and to acquisition and operation of utilities

HB 356	BROSSETT	MUNICIPALITIES/NO Provides relative to the appointment and terms of members of the Public Belt Railroad Commission for the city of New Orleans

HB 374	RICHARDSON	LOCAL OFFL/POLICE CHIEFS Provides relative to the powers granted to elected police chiefs in municipalities governed by the Lawrason Act
HB 451	DOVE	DISTRICTS/HOSPITAL SERVC Provides relative to the terms of the board of commissioners of Hospital Service District No. 1 of Terrebonne Parish
HB 461	BROSSETT	DISTRICTS/NEIGHBORHOOD Provides relative to the boundaries of the Lake Oaks Subdivision Improvement District in the city of New Orleans
HB 517	LEBAS	EDUCATION Relative to the Council for the Development of French in La. (CODOFIL), provides for per diem and expenses of members and authorizes French-speaking elected officials to serve as nonvoting council members
HB 576	LEGER	HEALTH Provides with respect to the Greater New Orleans Biosciences Economic Development District
HB 613	MORRIS	DISTRICTS/HOSPITAL SERVC Authorizes the governing authority of the North Caddo Hospital Service District to levy a sales and use tax within the boundaries of the district
HB 619	LEGER	DISTRICTS/SPECIAL Creates the La. Sports and Entertainment District in New Orleans
