HB 68	SEABAUGH	COURTS/JUSTICE OF PEACE Provides for deputy constables of the justice of the peace court in Caddo Parish
HB 103	THIERRY	CLERKS OF COURT Authorizes an automobile expense allowance for the St. Landry Parish Clerk of Court
HB 226	ARNOLD	ALCOHOLIC BEVERAGE PERMT Authorizes the suspension or revocation of alcoholic beverage permits for supplying false information or failing to provide information
HB 315	HAVARD	COURTS/DISTRICT Provides for the determination of court reporter fees for transcriptions in the 20 th JDC
HB 355	POPE	COURTS/CITY Authorizes an increase in fees for criminal bonds posted in the Denham Springs City Court
HB 426	MORRIS, JAY	COURTS/JUSTICE OF PEACE Provides relative to venue in justice of the peace courts
HB 502	BISHOP, WESLEY	ALCOHOLIC BEVERAGE PERMT Provides relative to the alcoholic beverage control board in New Orleans
HB 522	ARNOLD	SALES/TOBACCO TRADE Prohibits alcoholic beverage and tobacco licensees from accepting food stamps as payment for products
HB 523	ARNOLD	ALCOHOLIC BEVERAGE PERMT Provides for permitting fees collected by the commissioner of alcohol and tobacco control
HB 555	ARNOLD	ALCOHOLIC BEVERAGE PERMT Provides for a sales tax clearance form to be submitted with original and renewal applications for alcoholic beverage permits

HB 592	MORRIS, JAY	COURTS/DISTRICT Provides for special divisions or sections in district courts
HB 746	CHANEY	STATE SYMBOL Designates the pirogue as the official state boat
HB 757	ARNOLD	ALCOHOLIC BEVERAGE PERMT Provides for specific alcoholic beverage permit requirements
HB 777	FOIL	COURTS/CITY Increases the jurisdictional limit for small claims divisions of city courts
HB 858	BISHOP, WESLEY	MUNICIPALITIES/NO Provides relative to alcoholic beverage permits in New Orleans
SB 109	MORRELL	FEES/LICENSES/PERMITS Authorizes the commissioner of the office of alcohol and tobacco control to set permit fees pursuant to the regulations up to a maximum amount. (8/1/12)
SB 110	MORRELL	REVENUE DEPARTMENT Authorizes Alcohol and Tobacco Control to create sanctions for violations related to supplying false information. (8/1/12)
SB 117	MORRELL	CIGARS/CIGARETTES Prohibits alcoholic beverage licensees from accepting nutritional assistance benefits as payment for alcohol and tobacco products. (8/1/12)
SB 262	MORRELL	FEES/LICENSES/PERMITS Provides relative to qualifications of applicants for alcoholic beverage permits. (8/1/12)
SB 366	MORRELL	ALCOHOLIC BEVERAGES Provides relative to certain forms submitted with alcoholic beverage permit applications. (8/1/12)
