1. **HCR5** **SCHRODER** **CHILDREN** Continues the Task Force on Legal Representation in Child Protection Cases
2. **HCR7** **HENSGENS** **DISTRICTS/DRAINAGE** Memorializes congress to assist the Vermilion Parish Police Jury regarding the permitting process and mitigation requirements involving maintenance performed by drainage districts
3. **HCR23** **ORTEGO** **TRANSPORTATION** Creates the Uniform Bilingual Signage and Map Task Force
4. **HCR42** **SCHEXNAYDER** **CONGRESS** Memorializes congress to encourage and enable the U.S. Army Corps of Engineers to expedite their wetlands permitting process
5. **HCR65** **GISCLAIR** **TRANSPORTATION DEPT** Requests DOTD to conduct a traffic study
6. **HCR76** **P.SMITH** **PRIVILEGES/LIENS** Requests the La. State Law Institute to study and make recommendations regarding unpaid wages
7. **HCR81** **HUVAL** **CIVIL/JURY TRIALS** Requests the Louisiana State Law Institute to study and make recommendations for legislation relative to expedited jury trials
8. **HCR93** **BILLIOT** **CIVIL/OBLIGATIONS** Requests the La. State Law Institute to study and make recommendations relative to suretyship
9. **HCR84** **K.JACKSON** **HEALTH** Urges and requests the Dept. of Health and Hospitals and the La. Hospital Association to promote and encourage all hospitals and medical clinics that receive state dollars to promote the "Text4baby" initiative
10. **HCR96** **SIMON** **HEALTH SERVICES** Requests a study of means by which to expand access to telehealth services in La.

1. **HB411** **ABRAMSON** **PUBLIC PROPERTY** Provides relative to the sale of educational facilities and property in Orleans Parish
2. **HB761** **HONORE** **SCHOOLS/FOOD PROGRAMS** Provides relative to the administration of nutrition programs at LSU and Southern lab schools

HOUSE BILLS ON FINAL PASSAGE-R - [25 items]

1. **HB711** **PUGH** **ELECTIONS/CANDIDATES** Provides for the requirements of the notice of candidacy by additionally requiring a candidate for major or district office to certify that he has filed any campaign finance reports previously due
2. **HB720** **LEGER** **CONTRACTS** Establishes the La. First Hiring Act to promote the hiring of residents of La.'s coastal parishes for public works projects for coastal restoration and protection
3. **HB756** **ABRAMSON** **PUBLIC RECORDS** Exempts certain materials of higher education boards and institutions from disclosure under the Public Records Law
4. **HB768** **T.BURNS** **CONGRESS/DISTRICTS** Provides with respect to membership on various boards, commissions, and entities that is based on congressional districts
5. **HB1016** **POPE** **CHILD DAY CARE** Provides for duties of the Dept. of Children and Family Services relative to licensure of day care centers and facilitation of the La. Advisory Council on Child Care and Early Education
6. **HB1036** **BROSSETT** **ELECTIONS/COMMISSIONERS** Authorizes an increase in compensation of absentee by mail and early voting commissioners for certain elections
7. **HB1067** **ST.GERMAIN** **ENVIRONMENT/WASTE SITES** Provides for reimbursement for processing waste tires
8. **HB1095** **LEGER** **ELECTIONS/PRESIDENTIAL** Makes the state of La. a party to an interstate compact entitled the "Agreement Among the States to Elect the President by National Popular Vote"
9. **HB1102** **LIGI** **REVENUE DEPARTMENT** Authorizes the disclosure of certain taxpayer information to the La. Clerks' of Court Association
10. **HB1113** **JOHNSON** **PUBLIC RECORDS** Exempts the La. Licensed Professional Counselors Board of Examiners from certain provisions of Public Records Law
11. **HB1203** **P.WILLIAMS** **TAX/SALES-USE, LOCAL-EXEM** Beginning Jan. 1, 2014, exempts prescription drugs and pharmacists services from local sales and use taxes
12. **HB1204** **PYLANT** **DWI** Provides relative to the reinstatement of driving privileges associated with a violation of criminal law and extends time in which to request an administrative hearing following a DWI arrest
13. **HB1205** **JOHNSON** **CHILDREN/SUPPORT** Provides for the transfer of a child support obligation to a caretaker
14. **HB395** **CARMODY** **COLLEGES/UNIVERSITIES** Provides relative to the expenditure or allocation of funds appropriated to postsecondary education management boards
