HB 117	BURNS, HENRY	MTR VEHICLE/COMMERCIAL Prohibits commercial motor vehicle drivers who have been issued certain waivers from driving commercial motor vehicles for public utilities
HB 124	EDWARDS	MTR VEHICLE/LICEN PLATES Creates the Korean Defense Service license plate
HB 133	ARMES	MTR VEHICLE/DRIVER LIC Authorizes the placement of "VETERAN" on drivers' licenses and special identification cards
HB 205	BERTHELOT	MTR VEHICLE/LICEN PLATES Authorizes the use of prestige license plates on certain trucks
HB 234	HODGES	MTR VEHICLE/LICEN PLATES Creates a prestige license plate to protect the honeybee
HB 310	PONTI	MTR VEHICLE/DISMANTLERS Provides relative to the issuance of permits to dismantle motor vehicles which are more than 15 years old
HB 323	HOFFMANN	MTR VEHICLE/LICEN PLATES Provides for the advertisement of the availability of specialty and prestige plates
HB 425	BROSSETT	MTR VEHICLE/LICEN PLATES Creates a special "For Hire" license plate for use in the city of New Orleans
HB 484	PUGH	MTR VEHICLE/DRIVER LIC Requires drivers' licenses to include a special code indicating the holder has a lifetime hunting license in the state of La.
HB 505	HOFFMANN	MTR VEHICLE/OFFICE Provides OMV with authority to place advertisements on certain material

HB 544	MONTOUCET	MTR VEHICLE/DRIVER LIC Requires a licensed driver who OMV has reason to believe to be unqualified to drive to submit to the written and skills test
HB 585	ST. GERMAIN	INSURANCE/AUTOMOBILE Requires proof of financial responsibility and notice of cancellation or termination to be submitted electronically
HB 586	ST. GERMAIN	MTR VEHICLE/DRIVER LIC Increases the age by which a person must submit a signed statement attesting to supervised driving practice when issued a Class "E" driver's license for the first time
HB 587	ST. GERMAIN	MTR VEHICLE/COMMERCIAL Provides relative to the disqualification of commercial motor vehicle drivers
HB 588	ST. GERMAIN	MTR VEHICLE/LICEN PLATES Extends the time for which special temporary registration plates or markers are valid
HB 590	ST. GERMAIN	VETERANS Exempts veterans from the payment of fees for special identification cards
HB 668	ST. GERMAIN	MTR VEHICLE/COMMERCIAL Provides relative to certifications made by persons applying for CDL license
HB 696	ST. GERMAIN	MTR VEHICLE/COMMERCIAL Provides for the testing and licensing of commercial motor vehicle drivers and third parties who give commercial motor vehicle driving tests and examinations
HB 704	ANDERS	MOTOR VEHICLES Authorizes the licensing of titled-movable transfer officers to notarize vehicle titles and bills of sale
HB 814	HILL	MTR VEHICLE/LICEN PLATES Creates the Forestry Prestige License Plate
HB 832	HAZEL	MTR VEHICLE/LICEN PLATES Creates the Town of Ball 40 th Anniversary Prestige License Plate
