<b>HCR 41</b>	<b>ORTEGO</b>	<b>HONORARY DESIGNATIONS</b> Designates the city of Scott as the Boudin Capital of the World
<b>HB 16</b>	<b>MORRIS, JAY</b>	<b>COURTS/MAYORS</b> Authorizes an increase in court costs for municipal ordinance violations in the mayor's court in the town of Sterlington
<b>HB 24</b>	<b>BURNS, HENRY</b>	<b>INSURANCE/GROUP-SHERIFFS</b> Relative to the payment of group insurance premiums for retired sheriffs and employees of the Bossier Parish Sheriff's Office
<b>HB 37</b>	<b>GISCLAIR</b>	<b>COURTS/MAYORS</b> Provides for additional court costs for the Lockport Mayor's Court
<b>HB 67</b>	<b>FANNIN</b>	<b>SHERIFFS</b> Provides relative to payment of group insurance premiums for retired sheriffs and deputy sheriffs of the Winn Parish Sheriff's Office
<b>HB 78</b>	<b>POPE</b>	<b>INSURANCE/GROUP-SHERIFFS</b> Provides relative to the administration of the Livingston Parish Retired Employees' Insurance Fund
<b>HB 101</b>	<b>EDWARDS</b>	<b>COURTS/COURT COSTS</b> Authorizes an increase in fees or court costs for the 21 <sup>st</sup> Judicial District Court
<b>HB 352</b>	<b>BURFORD</b>	<b>INSURANCE/GROUP-SHERIFFS</b> Creates a fund to pay group insurance premiums for retired sheriffs and deputy sheriffs in DeSoto Parish
<b>HB 402</b>	<b>EDWARDS</b>	<b>COURTS</b> Relative to the 21 <sup>st</sup> Judicial District Court's Judicial Expense Fund
<b>HB 503</b>	<b>ARNOLD</b>	<b>TRAFFIC/VIOLATIONS</b> Provides for jurisdiction with respect to certain traffic violations
<b>HB 521</b>	<b>MORENO</b>	<b>COURTS</b> Expands the workforce development sentencing program to include additional judicial districts
<b>HB 685</b>	<b>MORENO</b>	<b>LAW ENFORCEMENT</b> Provides procedures for the investigation of officers and employees by the NOPD

<b>HB 721</b>	<b>MORENO</b>	<b>JUDGMENTS/CIVIL</b> Provides for a fee paid to the attorney general from tobacco product manufacturers for certification
<b>HB 873</b>	<b>ARNOLD</b>	<b>TRAFFIC/VIOLATIONS</b> Authorizes the Traffic Court of New Orleans to exercise appellate jurisdiction in de novo appeals for violations from a traffic camera citation
<b>HB 953</b>	<b>LEGER</b>	<b>COURTS</b> Provides relative to the consolidation of courts in Orleans Parish
<b>HB 960</b>	<b>JOHNSON</b>	<b>COURTS</b> Authorizes additional court costs for criminal matters in the 12 <sup>th</sup> Judicial District Court
<b>HB 1006</b>	<b>PYLANT</b>	<b>INSURANCE/GROUP-SHERIFFS</b> Provides relative to the payment of insurance premiums for retirees of the Franklin Parish Sheriff's Office
