<b>HB 59</b>	<b>HONORE</b>	<b>CRIMINAL/SENTENCING</b> Increases the total number of credits that may be earned by an offender for participation in certified treatment and rehabilitation programs
<b>HB 105</b>	<b>WHITNEY</b>	<b>CLERKS OF COURT</b> Provides for the functions of the jury commission in Terrebonne Parish
<b>HB 145</b>	<b>MORRIS, JAY</b>	<b>SEX OFFENSE/REGISTRY</b> Provides relative to sex offender registration and notification requirements for offenders convicted pursuant to the laws of another state who establish a residence in La.
<b>HB 167</b>	<b>CHAMPAGNE</b>	<b>CRIMINAL/PROCEDURE</b> Provides relative to the type of information provided to an institution of postsecondary education requesting criminal history information for an applicant or prospective employee
<b>HB 189</b>	<b>GAINES</b>	<b>CRIME/THEFT</b> Provides relative to the attempt to commit the crime of theft
<b>HB 279</b>	<b>HENRY</b>	<b>CRIME</b> Amends the definition of the crime of racketeering
<b>HB 335</b>	<b>PYLANT</b>	<b>CORR FACILITIES/JAILS</b> Provides relative to the housing of prisoners in correctional facilities
<b>HB 349</b>	<b>PRICE</b>	<b>CRIME/ESCAPE</b> Provides relative to simple escape from a work release program
<b>HB 361</b>	<b>RITCHIE</b>	<b>CRIME</b> Provides relative to the use of a tracking device to track the location or movements of a minor child by parents

**CRIME** Creates the crime of forgery of a motor vehicle inspection certificate and provides criminal penalties for the commission of such offense
