<b>HB 83</b>	<b>BROSSETT (TBA)</b>	<b>BONDS</b> Provides for the forgiveness of loans under the Local Debt Service Assistance Program <b>(Subject to Rule Suspension)</b>
<b>HB 139</b>	<b>LEOPOLD (TBA)</b>	<b>TAX/SALES-USE, ST-EXEMPT</b> Creates an exemption from sales and use tax for construction materials purchased by the Committee for Plaquemines Recovery <b>(Subject to Rule Suspension)</b>
<b>HB 682</b>	<b>HOLLIS (TBA)</b>	<b>TAX/SALES &amp; USE</b> Broadens the sales and use tax exclusion for gold, silver, or numismatic coins, or platinum, gold, or silver bullion <b>(Subject to Rule Suspension)</b>
<b>HB 688</b>	<b>JOHNSON (TBA)</b>	<b>TAX CREDITS</b> Provides a credit against income and corporation franchise tax liability to certain businesses which offer essential services during emergency situations <b>(Subject to Rule Suspension)</b>
<b>SB 63</b>	<b>MILLS (TBA)</b>	<b>ASSESSORS</b> Authorizes each assessor to increase his compensation by up to 4% each calendar year for four years beginning 2013. (7/1/13) <b>(Subject to Rule Suspension)</b>
<b>SB 78</b>	<b>MARTINY (TBA)</b>	<b>TAX/SALES</b> Provides for certain tax authorities to grant an exclusion from sales tax for repairs to certain property which is delivered out of state. (7/1/13) <b>(Subject to Rule Suspension)</b>
<b>SB 96</b>	<b>ADLEY (TBA)</b>	<b>TAX/AD VALOREM</b> Constitutional amendment to provide for eligibility for disabled veterans and their spouses for certain exemptions from ad valorem taxes. (2/3 - CA13s1(A)) <b>(Subject to Rule Suspension)</b>
<b>SB 165</b>	<b>MARTINY (TBA)</b>	<b>TAX/TAXATION</b> Requires a qualified cost report prior to issuance of a motion picture investor tax credit. (8/1/13) <b>(Subject to Rule Suspension)</b>
<b>SB 255</b>	<b>CLAITOR (TBA)</b>	<b>TAX/TAXATION</b> Limits the solar energy systems tax credit to one for each residence or for each dwelling unit in a residential rental apartment project. (gov sig) <b>(Subject to Rule Suspension)</b>

**TAX/TAXATION** Prohibits the alternative fuel tax credit for certain flexible fuel vehicles. (gov sig)
