_____	<b>HB 436</b>	<b>FANNIN</b>	<b>REVENUE DEPARTMENT</b> Provides for the payment methods for refunds of overpayments of individual income tax
_____	<b>HB 538</b>	<b>ST. GERMAIN</b>	<b>MTR VEHICLE/DEALERS</b> Authorizes the vehicle commissioner to extend the time to remit taxes and to waive certain tax penalties
_____	<b>HB 586</b>	<b>THIBAUT</b>	<b>ASSESSORS</b> Requires the assessor in certain parishes to pay the cost of certain insurance premiums for eligible retirees from the assessor's office
_____	<b>HB 708</b>	<b>GAROFALO</b>	<b>TAX/TAX REBATES</b> Defines "qualified capital expenditures" eligible for a project facility expense rebate through the Competitive Projects Payroll Incentive Program
_____	<b>HB 712</b>	<b>GREENE</b>	<b>TAX/SEVERANCE TAX</b> Prohibits the state from paying interest on refunds for the overpayment of certain severance taxes
_____	<b>HB 713</b>	<b>GREENE</b>	<b>TAX/SEVERANCE TAX</b> Provides that severance taxes do not have to be paid during the period of a suspension or exemption from severance tax when the well operator holds a certificate of good standing
_____	<b>HB 780</b>	<b>TALBOT</b>	<b>TAX/TAX REBATES</b> Provides relative to the requirements of certain school tuition organizations and the definition of a "qualified student" for purposes of the rebate
_____	<b>HB 798</b>	<b>STOKES</b>	<b>TAX/STATE</b> Provides relative to the enforcement and adjudication of state taxes

_____	<b>HB 847</b>	<b>PUGH</b>	<b>TAX/SALES &amp; USE</b> Requires the filing of an annual use tax return for the payment of use tax on taxable tangible personal property and services purchased from a remote seller
_____	<b>HB 912</b>	<b>BARROW</b>	<b>REVENUE DEPARTMENT</b> Provides relative to the manner in which the Department of Revenue may issue refunds for overpayments and requires a certain period for the activation of debit cards
_____	<b>HB 1042</b>	<b>RITCHIE</b>	<b>TAX COMMISSION, STATE</b> Extends authorization for the La. Tax Commission to levy and collect certain fees
