**INSTRUMENTS TO BE HEARD:**

<b>HB 467</b>	<b>CARMODY</b>	<b>MOTOR VEHICLES</b> Regulates transactions involving wrecked, abandoned, or repairable motor vehicles and creates a reporting database
<b>HB 669</b>	<b>HUNTER</b>	<b>CONSUMERS/PROTECTION</b> Prohibits rental car companies from charging a fee for additional authorized drivers
<b>HB 677</b>	<b>MACK</b>	<b>AUCTIONS/AUCTIONEERS</b> Provides with respect to continuing education for auctioneers
<b>HB 870</b>	<b>STOKES</b>	<b>ACCOUNTANTS/CPA</b> Provides for revisions relative to the Louisiana Accountancy Act
<b>HB 923</b>	<b>LOPINTO</b>	<b>MOTOR VEHICLES</b> Provides for unauthorized acts relative to motor vehicles
<b>HB 952</b>	<b>MORENO</b>	<b>FIRE PROTECT/FIRE MARSHAL</b> Provides with respect to short-term rental structures
<b>HB 1040</b>	<b>JAMES</b>	<b>TELECOMMUNICATIONS</b> Regulates the manufacture, sale, and lease of telephones with respect to smartphone encryption technology
<b>HB 1094</b>	<b>IVEY</b>	<b>CREDIT/CONSUMER</b> Prohibits the submission of certain consumer records of unpaid traffic fines to credit reporting agencies
<b>HB 1118</b>	<b>HUNTER</b>	<b>TELECOMMUNICATIONS</b> Authorizes certain fiduciaries to exercise control respecting the digital property of decedents and other certain persons
<b>SB 128</b>	<b>MARTINY</b>	<b>COMMERCIAL REGULATIONS</b> Provides relative to self-service storage facilities. (gov sig)
