HB 236	THIBAUT	MOTOR VEHICLES Provides grace period in order to pay certain taxes and fees related to motor vehicles for persons separating from active duty military service
HB 426	BROADWATER	TAX RETURN Establishes qualifications for the issuance of a Direct Payment Number for purposes of payment of sales and use taxes
HB 505	JOHNSON, M.	TAX/AD VALOREM TAX (Constitutional Amendment) Exempts widows of military personnel killed in the line of duty from payment of any ad valorem taxation on their personal property
HB 695	BROADWATER	REVENUE DEPARTMENT Provides relative to the types of debt the office of debt recovery is charged with collecting
HB 697	JONES	REVENUE SECRETARY Authorizes the secretary of the Dept. of Revenue to waive penalties under certain conditions
HB 722	MORENO	REVENUE DEPARTMENT Provides relative to registration of certain online hotel marketplaces and collection of the tax imposed on certain online hotel sales
HB 735	ABRAMSON	TAX RETURN Provides relative to the deadlines for the payment of certain taxes and the time and place for the filing of certain income tax returns
HB 737	ABRAMSON	REVENUE DEPARTMENT Changes the deadline for the submission of annual reports to the Department of Revenue regarding deductions and withholdings of employee wages

HB 738	ABRAMSON	REVENUE DEPARTMENT Provides relative to the enforcement and supervision of the collection of certain inspection and supervision fees
HB 755	ABRAMSON	SUNSET LAW Re-creates the Department of Revenue
HB 756	ABRAMSON	REVENUE DEPARTMENT Requires the electronic filing of certain claims for refunds
HB 772	ABRAMSON	TAX/TAX REBATES Provides relative to certain rebate programs
HB 776	ABRAMSON	REVENUE DEPARTMENT Provides for remittance of sales and use tax under protest
HB 783	ABRAMSON	TAX/TAX REBATES Relative to the Louisiana Quality Jobs Program
HB 794	ABRAMSON	TAX/TAX REBATES Provides relative to the Competitive Projects Payroll Incentive Program
HB 795	STOKES	TAX EXEMPTIONS Provides relative to the organization of the Tax Expenditure Budget

DISCUSSION: The Ways and Means Committee will begin accepting written testimony regarding any tax expenditure included in the Tax Exemption Budget published by the Department of Revenue, including expenditures for individual income, corporate income, corporate franchise, alcoholic beverages, severance, petroleum products, public utilities and carriers, sales and use, telecommunications, and tobacco taxes and tax incentives and exemption contracts. The committee will conduct hearings at a later date based on the written testimony received. A link to the form for submitting written testimony will be included at the bottom of each meeting agenda beginning on March 29, 2016. Written testimony shall be submitted electronically and in hard copy to the committee no later than April 30, 2016.
