(b) The exercising of a corporation's charter or the continuance of its charter within this state.

(c) The owning or using any part or all of its capital, plant, or other property in this state whether owned directly or indirectly by or through a partnership, joint venture, or any other business organization of which the domestic or foreign corporation is a related party as defined in R.S. 47:605.1.

(2) The tax levied pursuant to the provisions of this Chapter shall be limited to the following percentages of the amount otherwise levied pursuant to the provisions of this Chapter:

(a) For taxable years beginning on or after January 1, 2019, and before January 1, 2020, seventy-five percent.

(b) For taxable years beginning on or after January 1, 2020, and before January 1, 2021, fifty percent.

(c) For taxable years beginning on or after January 1, 2021, and before January 1, 2022, twenty-five percent.

(d) For taxable years beginning on or after January 1, 2022, no corporation franchise tax shall be assessed, levied, or collected by the state nor paid by domestic or foreign corporations on taxable capital.
