This report is for House Bill No. 541 of the 2018 Regular Session by Representative Stokes, proposing to amend Article III, Section 2(A)(3)(b) and to add Article III, Section 2(A)(5) of the Constitution.

HB 541 provides for the subject matters considered during regular legislative sessions.

II. CONCLUSION

The proposed measure cannot be accomplished statutorily.

HB 541 proposes to change the limitations on the subject matter of legislation which may be considered during even-numbered years, specifically allowing the consideration of measures levying or authorizing new taxes, tax exemptions, exclusions, deductions or credits. Since the constitution currently prohibits the consideration of such legislation in even-numbered years, the proposed changes can only be accomplished through an amendment to the constitution.
