PROCLAMATION

WHEREAS, a vacancy exists in the office of State Representative, District 18, Parishes of Pointe Coupee, West Feliciana, and West Baton Rouge, due to the resignation of Don Cazayoux, effective on May 6, 2008; and

WHEREAS, Louisiana Revised Statutes 18:601 provides that such vacancy shall be filled by special election called by the Speaker of the House; and

WHEREAS, Louisiana Revised Statutes 18:402 sets the dates for the special primary and the special general elections; and

NOW, THEREFORE I, Jim Tucker, Speaker of the House of Representatives of the Legislature of Louisiana issue this notice, call, and proclamation for a special primary and special general election to be held throughout the jurisdiction of Representative District 18, Parishes of Pointe Coupee, West Baton Rouge, and West Feliciana for the purpose of electing a State Representative.

Any qualified person desiring to become a candidate for the office shall file the notice of candidacy, accompanied either by a qualifying fee or a nominating petition, as required or authorized by law, with the appropriate election official in the manner and form and under the procedures and conditions provided by Subpart B of Part IV of Chapter 5, or any other applicable provision, of Title 18 of the Louisiana Revised Statutes of 1950, during the period commencing on Wednesday, July 9 and ending at 5:00 p.m. on Friday, July 11, 2008.


The election herein called, noticed, and provided for and proclaimed shall be held and conducted under the applicable provisions of the Louisiana Election Code, being Title 18 of the Louisiana Revised Statutes of 1950.

I hereby fix the date of the primary election for Saturday, October 4, 2008 and the date for the general election for Tuesday, November 4, 2008 at the times and places, and in the manner prescribed by law.

Accordingly, I now authorize, request, direct, and empower the Secretary of State, the Commissioner of Elections, the Parish Boards of Election Supervisors for the Parishes of Pointe Coupee, West Baton Rouge, and West Feliciana, the Clerks of Court for the Parishes of Pointe Coupee, West Baton Rouge, and West Feliciana, the Registrars of Voters for the Parishes of Pointe Coupee, West Baton Rouge, and West Feliciana and all other persons charged with any power, function, right, duty, or responsibility in conducting elections in the jurisdiction of Representative District 18, Parishes of Pointe Coupee, West Baton Rouge, and West Feliciana to exercise every lawful function, do every act necessary to conduct elections, cause the returns thereof to be made, and in general, to perform all related and incidental functions necessary to canvass and promulgate the results thereof.
