This resolution of the Vermilion Parish Police Jury, a political subdivision of the State of Louisiana, domiciled in Vermilion Parish, Louisiana, respectfully represents that:

WHEREAS, the Louisiana State House of Representatives ("House") is currently in the process of redistricting its 105 member districts; and

WHEREAS, portions of the Parish of Vermilion have heretofore been divided into:

- District 49, represented by Simone Champagne
- District 31, represented by Nancy Landry, and
- District 47, represented by Jonathan Perry; and

WHEREAS, the Vermilion Parish Police Jury wishes to express its sincere appreciation to Representative Simone Champagne, Representative Nancy Landry and Representative Jonathan Perry for their dedication and diligence in representing the interests of the people of Vermilion Parish; and

WHEREAS, the Vermilion Parish Police Jury believes that the interests of the people of Vermilion Parish will be better served in the future by representation of only two (2) members of the House of Representatives and that Vermilion Parish should be divided into no more than two (2) House Election Districts.


