<b>HB 463</b>	<b>MARTINY</b>	<b>GAMBLING/VIDEO POKER:</b> Provides that licensees do not have to submit designated representative information
<b>HB 464</b>	<b>MARTINY</b>	<b>GAMBLING/VIDEO POKER:</b> Provides for the issuance of additional licenses without additional suitability determinations
<b>HB 465</b>	<b>MARTINY</b>	<b>GAMBLING/VIDEO POKER:</b> Defines designated representative and provides for the issuance of designated representative permits
<b>HB 504</b>	<b>MARTINY</b>	<b>CORRECTIONS:</b> Amends provisions regarding eligibility to participate in the work release program
<b>HB 505</b>	<b>MARTINY</b>	<b>CORRECTIONS:</b> Provides criteria for the assignment of inmates at the Work Training Facility North
<b>HB 507</b>	<b>MARTINY</b>	<b>CRIMINAL/PENALTIES:</b> Relative to forfeiture of good time
<b>HB 508</b>	<b>MARTINY</b>	<b>CRIMINAL/PENALTIES:</b> Relative to eligibility for diminution of sentence for good behavior
<b>HB 706</b>	<b>MARTINY</b>	<b>PARDON/PAROLE:</b> Provides for additional conditions of parole
<b>HB 707</b>	<b>MARTINY</b>	<b>PARDON/PAROLE:</b> Authorizes the court to require additional conditions of probation
<b>HB 752</b>	<b>CAZAYOUX</b>	<b>CRIMINAL/ARREST WARRANT :</b> Authorizes the issuance of an arrest warrant by fax
<b>HB 1041</b>	<b>CAZAYOUX</b>	<b>CORRECTIONAL FACILITIES :</b> Authorizes the Louisiana Correctional Facilities Corporation to sell any properties of the corporation which have not been used in the construction of a correctional facility
<b>HB 1324</b>	<b>MARTINY</b>	<b>CORRECTIONS/PRISONERS:</b> Provides for the release of certain information pertaining to a prisoner's activities while incarcerated
<b>HB 1383</b>	<b>DURAND</b>	<b>CRIMINAL/PROCEDURE:</b> Amends law regarding extradition costs and expenses
<b>HB 1463</b>	<b>TOWNSEND</b>	<b>GAMBLING/VIDEO POKER:</b> Amends provision regarding hours of operation for restaurant at a qualified truck stop licensed to operate video draw poker devices
