| <b>SB 72</b>  | <b>DUPRE</b>          | <b>DWI:</b> Prohibits mail order purchasing of an ignition interlock device required as a condition of probation for a DWI offense.  |
| <b>SB 77</b>  | <b>MOUNT</b>          | <b>CHILDREN:</b> Provides relative to proximity of licensed day care centers to certain alcohol service providers and places day care centers in drug free zones.  |
| <b>SB 98</b>  | <b>LENTINI</b>        | <b>CRIME/PUNISHMENT:</b> Revises provisions for limitation of access to immovable property under the crime of criminal trespass and provides for penalties.  |
| <b>SB 207</b> | <b>BOISSIERE</b>      | <b>CRIME/PUNISHMENT:</b> Increases the penalties for attempted crimes punishable by death or imprisonment at hard labor for not less than 10 nor more than 50 years without benefit of parole, probation, or suspension of sentence when attempted on a peace officer performing his duty. |
| <b>SB 295</b> | <b>DARDENNE (TBA)</b> | <b>DNA:</b> Repeals the limitation of prosecution relative to sex offenses under certain conditions when DNA evidence identifies the offender. (gov sig) <b>(Subject to Rule Suspension)</b>   |
| <b>SB 303</b> | <b>MOUNT</b>          | <b>CHILDREN:</b> Provides for the creation of multidisciplinary investigative teams for the investigation and disposition of cases of child abuse and neglect in each judicial district of the state and for the creation of child advocacy centers.                                       |
| <b>SB 304</b> | <b>DARDENNE</b>       | <b>DOMESTIC VIOLENCE:</b> Provides relative to the domestic violence.  |
| <b>SB 424</b> | <b>CHAISSON</b>       | <b>VIDEO POKER:</b> Provides for the scheduling of video poker games with no minimum wager.  |
| <b>SB 439</b> | <b>MOUNT</b>          | <b>DWI:</b> Requires impoundment of an offender's motor vehicle after an arrest for operating a vehicle while intoxicated.   |
| <b>SB 477</b> | <b>CHAISSON</b>       | <b>VIDEO POKER:</b> Provides relative to video draw poker devices.   |
| <b>SB 480</b> | <b>CHAISSON</b>       | <b>SEX OFFENSES:</b> Limits certain exemption from registration by a sex offender to a gubernatorial pardon.   |
| <b>SB 481</b> | <b>CHAISSON</b>       | <b>VIDEO POKER:</b> Provides for a change in the currency accepted in video draw poker devices.  |
| <b>SB 502</b> | <b>DARDENNE</b>       | <b>CRIME/PUNISHMENT:</b> Revises the circumstances regarding the victim's incapacity as an element of the crime of simple rape.  |

<b>SB 508</b>	<b>C D JONES</b>	<b>CRIMINAL JUSTICE:</b> Authorizes application to the Louisiana Risk Review Panel by persons sentenced to life imprisonment under certain conditions.
<b>SB 511</b>	<b>C D JONES</b>	<b>CONTROL DANGER SUBSTANCE:</b> Revises statute providing for penalties for possession of GHB (gamma hydroxybutyric acid) or its analogues, to eliminate inaccurate reference to Schedule II (D)(2) and provides relative to the definition of a controlled substance analogue.
<b>SB 522</b>	<b>C D JONES</b>	<b>DNA:</b> Extends post conviction relief period within which to file application for DNA testing and provides relative to indigent defense.
<b>SB 552</b>	<b>C D JONES</b>	<b>JUVENILE JUSTICE:</b> Provides for sentencing of juveniles based on race to be illegal.
<b>SB 627</b>	<b>IRONS</b>	<b>CRIME/PUNISHMENT:</b> Provides relative to the crimes of simple and aggravated cruelty to animals.
<b>SB 660</b>	<b>HEITMEIER</b>	<b>LAW ENFORCEMENT:</b> Authorizes active reserve or auxiliary law enforcement officers to carry weapons under certain conditions.
<b>SB 761</b>	<b>CAIN (TBA)</b>	<b>SEX OFFENSES:</b> Provides relative to the definition of aggravated rape and to the conditions of bail relative to such offense. <b>(Subject to Rule Suspension)</b>
<b>SB 801</b>	<b>MARIONNEAUX</b>	<b>EMPLOYMENT:</b> Allows certain employers to obtain criminal records of job applicant.
<b>SB 919</b>	<b>MALONE</b>	<b>GAMING:</b> Authorizes the state to enter into Indian gaming compacts with up to seven year terms and provides a process for compact negotiation and approval.
<b>SB 1027</b>	<b>JOHNSON</b>	<b>CRIME/PUNISHMENT:</b> Prohibits cross burning with an intent to intimidate.
<b>SB 1031</b>	<b>C ROMERO</b>	<b>LAW ENFORCEMENT:</b> Requires the investigation of an alleged violation of the crime of identify theft when requested by the victim and requires training of peace officers relative to such crime if funds are made available.
