| HB 351 | TOWNSEND | RETIREMENT/TEACHERS: Authorizes certain participants in the optional retirement plan to reestablish membership in the regular retirement plan of the Teachers' Retirement System |
| HB 354 | TOWNSEND | RETIREMENT/FIREFIGHTERS: Changes membership of the board of trustees |
| HB 412 | McVEA (TBA) | RETIREMENT/CLERKS COURT: Provides relative to conditions under which a cost-of-living adjustment may be granted by the board (Subject to Rule Suspension) |
| HB 417 | MURRAY (TBA) | RETIREMENT/JUDGES: Relative to judges in LASERS, provides for retirement at 60 without regard to years of service and provides relative to remaining in office after age 70 (Subject to Rule Suspension) |
| HB 527 | FAUCHEUX | RETIREMENT/MUNICIPAL EMP: (Constitutional Amendment) Allows participation in PERS, repayment of refunds, and transfer and purchase of service credit by a person who participated in PERS on or before January 1, 1977, including certain persons prohibited from parti |
| HB 565 | CRANE (TBA) | RETIREMENT/TEACHERS: Provides relative to the creditable service required for membership for part-time, seasonal, or temporary employees (Subject to Rule Suspension) |
| HB 617 | FAUCHEUX | RETIREMENT/PAROCHIAL EMP: Provides for system participation by persons in the system on or before 1/1/77, including part-time public officials |
| HB 759 | DANIEL (TBA) | RETIREMENT/TEACHERS: Provides for reemployment of retired Boyd Professors with fifty years on faculty at Louisiana State University (Subject to Rule Suspension) |
| HB 909 | SCHNEIDER | RETIREMENT/TEACHERS: Requires benefits paid to at least equal member's accumulated contributions (Subject to Rule Suspension) |
| HB 916 | SCHNEIDER (TBA) | RETIREMENT/TEACHERS: Provides with respect to benefits for certain minor children of deceased disability retirees (Subject to Rule Suspension) |
| HB 995 | LAFLEUR | RETIREMENT/JUDGES: Provides for retirement of judges and court officers with ten years of creditable service after attaining age sixty (Subject to Rule Suspension) |

HB 1084	POWELL	RETIREMENT/MUNICIPAL EMP: Includes certain supplements, fees, and commissions in the earnings of Hammond marshals (Subject to Rule Suspension)
HB 1188	SCHNEIDER (TBA)	RETIREMENT/STATE-STWIDE : Clarifies provisions relating to employee contributions (Subject to Rule Suspension)
HB 1192	TOWNSEND (TBA)	RETIREMENT SYSTEMS: Increases the amount of premium assessment funds allocated to certain statewide retirement systems and provides for allocation of that increase (Subject to Rule Suspension)
HB 1677	DANIEL (TBA)	RETIREMENT/SCHOOL EMPS: Authorizes persons in DROP or those continuing to work after completion of DROP to have their retirement recalculated at an accrual rate of 3 1/3% per year (Subject to Rule Suspension)
HB 1811	TRICHE (TBA)	RETIREMENT/TEACHERS: Requires employer to pay retiree the value of leave which cannot be converted to retirement credit (Subject to Rule Suspension)
HB 1925	SHAW	RETIREMENT/TEACHERS: Provides for purchase of credit for service as a school board member in the Teachers' Retirement System of Louisiana (Subject to Rule Suspension)
SB 131	HAINKEL (TBA)	RETIREMENT SYSTEMS: Provides annual cost-of-living adjustment for judges and widows of such judges who did not opt to become members of the Louisiana State Employees' Retirement System. (gov sig) (Subject to Rule Suspension)
SB 191	BOISSIERE (TBA)	TEACHERS RETIREMENT: Provides with respect to the Initial Lump-Sum Benefit. (7/1/03) (Subject to Rule Suspension)
SB 192	BOISSIERE (TBA)	PAROCHIAL EMPLOYEES RET : Provides for and creates an excess benefit plan for members of Parochial Employees' Retirement System of Louisiana. (gov sig) (Subject to Rule Suspension)
SB 193	BOISSIERE (TBA)	STATE EMPLOYEE RET: Removes the responsibility for Louisiana State Employees' Retirement System to verify state assistance of handicapped survivors. (gov sig) (Subject to Rule Suspension)
SB 195	BOISSIERE (TBA)	STATE EMPLOYEE RET: Removes the sunset date of July 1, 2003, for partial repayments of refunds. (gov sig) (Subject to Rule Suspension)
SB 196	BOISSIERE (TBA)	STATE EMPLOYEE RET: Provides for the payment of employee and employer contributions. (gov sig) (Subject to Rule Suspension)
SB 198	BOISSIERE (TBA)	STATE EMPLOYEE RET: Provides that the chairman of the Senate Retirement Committee shall receive per diem for attendance at board meetings. (gov sig) (Subject to Rule Suspension)
SB 201	BOISSIERE (TBA)	TEACHERS RETIREMENT: Provides with respect to rollover provisions. (7/1/03) (Subject to Rule Suspension)
SB 312	BOISSIERE (TBA)	STATE POLICE RET FUND: Provides retroactive eligibility for survivor benefits in limited circumstances where surviving spouse was married to decedent for less than two years prior to death. (gov sig) (Subject to Rule Suspension)
