INSTRUMENTS TO BE HEARD:

- HB 14** **FLAVIN** — LEGISLATIVE AUDITOR: Provides for the authority of the legislative auditor over certain high school athletic associations
- HB 352** **TOWNSEND** — AUDITS/AUDITING: Exempts justices of the peace and constables who derive less than \$5,000 from their office in a fiscal year from requirement for filing annual financial statement with the legislative auditor
- HB 576** **LEBLANC** — LEGISLATIVE AUDITOR: (Constitutional Amendment) Prohibits certain political activities by the legislative auditor and his employees and prohibits a former legislative auditor from qualifying for elected public office for two years after he leaves office
- HB 1701** **TOWNSEND** — LEGISLATIVE AUDITOR: Provides for the powers, duties, and functions of the legislative actuary
- HB 1744** **HUNTER** — ATHLETICS: Provides relative to the La. High School Athletic Association
- HB 1753** **TOWNSEND** — LEGISLATIVE AUDITOR: Provides for the legislative actuary
- SB 938** **SCHEDLER** — LEGISLATIVE AGENCIES: Provides for the legislative actuary.(07-01/03)
- HB 1787** **DEWITT** — LEGISLATIVE AUDITOR: Requires requests to the legislative auditor to examine, audit, review, investigate, or evaluate an entity to be in writing
- HB 1927** **HUNTER** — LEGISLATIVE AUDITOR: Adds to entities subject to audit by the legislative auditor
- HB 2001** **MURRAY** — LEGISLATIVE AUDITOR: Provides relative to the legislative auditor
- HR 73** **MURRAY** — HOUSE/RULES: Provides for recommittal to the House and Governmental Affairs Committee of bills providing exceptions to public records laws
- SB 412** **M SMITH** — LEGISLATIVE AUDITOR: Provides for exclusion of rural development monies in computing revenues necessary to require an audit.
- SB 746** **M SMITH** — FUNDS/FUNDING: Prescribes audit requirements for certain state entities with annual revenues of \$50,000 or less. (7/1/03)
- HCR 109** **FUTRELL** — TRANSPORTATION DEPT: Creates a special commission to evaluate the funding and efficiency of the Department of Transportation and Development
- HB 337** **BALDONE** — CRIMINAL/RECORDS: Provides for accessibility of criminal history records
