- **HCR 29 CROWE** U.S. CONSTITUTION: Memorializes congress to adopt a constitutional amendment providing that marriage shall consist only of the union of a man and a woman
- **HCR 139 BURNS** CHILDREN/CUSTODY: Requests the Marriage Persons Committee of the Louisiana State Law Institute to study the child custody and visitation laws
- **HCR 158 BOWLER** CHILDREN/VISITATION RGTS: Requests the Louisiana State Law Institute to study the visitation statutes
- **HCR 159 SHEPHERD** CIVIL/PROCESS: Requests Louisiana State Law Institute to study the procedures for providing notice of executory judgments
- **HB 127** MURRAY LIABILITY/CIVIL: Provides for the liability of public entities as a party to certain contracts
- **HB 433 TOWNSEND** PROPERTY/EXPROPRIATION: Provides for the reacquisition of expropriated property upon failure to begin construction
- HB 625 CAZAYOUX CIVIL/DAMAGES: Provides for liability of certain tortfeasors for damages
- **HB 659 GLOVER** CORRECTIONS/PRISONERS: Creates a cause of action for damages by persons who are wrongfully convicted
- **HB 766** GALLOT LIABILITY/CIVIL: Provides for limitations of liability for clerks of court
- **HB 771 JOHNS** EVIDENCE: Provides relative to the effect of failure to use a safety belt with regard to recovery of damages
- **HB 796** TOOMY SCHOOLS/BOARDS: (Constitutional Amendment) Limits state mandates increasing the financial burden of local school boards (**Technical Review Only**)
- **HB 851 PINAC** MORTGAGES: Prohibits conversion of collateral having a secured interest
- **HB 1021 DANIEL** MINERALS/LEASES: Provides restoration of property subject to a mineral lease
- HB 1032 BAUDOIN HEALTH CARE: Provides relative to the patient's bill of rights
- **HB 1162 DOVE** LIABILITY/CIVIL: Limits liability for damages to oyster beds
- **HB 1190 JEFFERSON** PRIVILEGES/LIENS: Provides for the enforcement of liens and privileges against an owner
- **HB 1267** GLOVER LIABILITY: Creates a cause of action for compensation for wrongful conviction and imprisonment
- **HB 1410 LAFLEUR** JUDGMENTS/CIVIL: Requires the social security number of the defendant to be included in certain petitions and judgments

- **HB 1496 LABRUZZO** PROPERTY/IMMOVABLE: Provides for the enforcement of building restrictions
- **HB 1505 HUNTER** MORTGAGES: Requires the mortgage to cancel the mortgage inscription
- **HB 1539 HOPKINS** MINERALS/LEASES: Provides for lessor to receive a certified copy of a mineral lease
- **HB 1581** GALLOT PRIVILEGES/LIENS: Provides a privilege for payment of public assistance services
- **HB 1643** FARRAR LABOR/ARBITRATION: Provides for applicability of the Louisiana Arbitrations Law
- **SB 635 BARHAM** NOTARIES: Provides for one year period of prescription and three year period of peremption for filing of actions against notaries. (gov sig)
