- HB 194 ANSARDI RETIREMENT/SCHOOL EMPS:** Authorizes persons in DROP on 7/1/01 or those continuing to work on 7/1/01 after completion of DROP to have their retirement recalculated at an accrual rate of 3 1/3% per year
- HB 836 GLOVER (TBA) RETIREMENT/POLICE FUNDS :** Provides with respect to benefits from the Policemen's Pension and Relief Fund of the City of Shreveport for a surviving widow and for benefits upon remarriage **(SUBJECT TO RULE SUSPENSION)**
- HB 870 TUCKER (TBA) RETIREMENT/FIREFIGHTERS :** Removes provisions authorizing retirees to participate in DROP **(SUBJECT TO RULE SUSPENSION)**
- HB 938 TUCKER (TBA) RETIREMENT/STATE SYSTEMS:** Requires systems to submit report on utilization of La. broker-dealers **(SUBJECT TO RULE SUSPENSION)**
- HB 1161 TUCKER (TBA) RETIREMENT/STATE EMPS:** Creates a defined contribution plan for persons hired on or after July 1, 2004 **(SUBJECT TO RULE SUSPENSION)**
- HB 1305 TRICHE RETIREMENT/STATE EMPS:** Allows certain participants in the Deferred Retirement Option Plan to rescind participation in the plan and regain membership in the system
- HB 1553 ARNOLD (TBA) RETIREMENT/JUDGES:** Provides for participation in the Deferred Retirement Option Plan **(SUBJECT TO RULE SUSPENSION)**
- HB 1563 E GUILLORY RETIREMENT/STATE EMPS:** Provides with respect to membership in the Louisiana State Employees' Retirement System for employees of certain political subdivisions
- SB 243 BOISSIERE (TBA) RETIREMENT SYSTEMS:** Provides for the eligibility of certain benefits for the attorney general. **(SUBJECT TO RULE SUSPENSION)**
- SB 290 BOISSIERE (TBA) PAROCHIAL EMPLOYEES RET :** Provides with respect to DROP and member contributions. (gov sig) **(SUBJECT TO RULE SUSPENSION)**
