HB 86	WALKER	APPROPRIATIONS/JUDGMENT Payment of judgment against the Department of Transportation and Development in the suit entitled "Bryan Joseph Mayeux, et ux v. Lambert's Contractors, Inc., et al."
HB 120	HILL	STUDENT/LOANS-SCHOLARSHIP Provides, relative to initial eligibility for a TOPS award beginning with the 2005-2006 award year, for minimum scores on specified standardized tests that are required of certain home study students
HB 169	TUCKER	APPROPRIATIONS Appropriates funds to provide for reimbursement of legal expenses of Alan J. LeVasseur, as recommended by the Attorney Fee Review Board
HB 244	WALSWORTH	PUBLIC SFTY/CORRECT DEPT Requires annual salary schedule of state police to be prepared by superintendent and provides for scope of review and implementation of recommendations concerning such schedule
HB 352	CROWE	PROBATION Provides relative to the Sex Offender Registry Technology Fund
HB 407	TUCKER	RACING/REVENUES Provides for dedication of revenues from slots at the track
HB 472	BARROW	CHILDREN/ABUSE Assesses an additional \$2 fee on the subsequent issuance of a death certificate
HB 543	CAZAYOUX	INSURANCE/GROUP-STATE Authorizes parish and city school systems to reduce the employer portion of premiums for the boards employees when a deficit is projected and requires the state to pay the difference
HB 588	POWELL, M.	BUDGETARY PROCEDURES (Constitutional Amendment) Requires that a certain portion of any increases in the official forecast be used to provide a state salary supplement for classroom teachers
HB 623	LAFLEUR	FUNDS/FUNDING Provides for the distribution of revenues deposited in the St. Landry Parish Excellence Fund
HB 643	ERDEY	APPROPRIATIONS/LEGAL EXP Appropriates funds to provide for reimbursement of legal expenses of Jeffery Hughes
HB 663	GLOVER	PARDON/PAROLE Creates an application process for persons incarcerated to apply for compensation upon proof of factual innocence

PROCUREMENT Provides relative to the procurement of medical and laboratory supplies and medical equipment
