<b>HB 213</b>	<b>SMITH, JANE</b>	<b>SUCCESSIONS</b> Provides for nonprobate transfers on death
<b>HB 273</b>	<b>ARNOLD</b>	<b>TAX/AD VALOREM TAX</b> (Constitutional Amendment) Limits increases in millages after reappraisal ( <i>Technical Review Only</i> )
<b>HB 370</b>	<b>FAUCHEUX</b>	<b>ASSESSORS/PROPERTY ASSMT</b> (Constitutional Amendment) Freezes the tax assessment of the homestead of a person who is designated as disabled by the U.S. Social Security Administration ( <i>Technical Review Only</i> )
<b>HB 433</b>	<b>QUEZAIRE</b>	<b>CHILDREN/VISITATION RGTS</b> Provides relative to violations of visitation orders
<b>HB 573</b>	<b>KENNARD</b>	<b>TAX/AD VALOREM-EXEMPTION</b> (Constitutional Amendment) Provides for an exemption for honorably discharged disabled military veterans based upon their percentage of disability ( <i>Technical Review Only</i> )
<b>SB 48</b>	<b>THEUNISSEN</b>	<b>LIABILITY</b> Provides immunity from liability for gravity drainage or sub-drainage districts for certain clearing of vegetation or application of pesticide. (gov sig)
<b>SB 111</b>	<b>SMITH, MIKE</b>	<b>LIABILITY</b> Includes the Toledo Bend Dam within the limitation of liability for damages for failure of a dam.
<b>SB 151</b>	<b>GAUTREAUX, N.</b>	<b>MILITARY AFFAIRS</b> Provides certain benefits for active military personnel regarding contractual matters. (gov sig)
<b>SB 184</b>	<b>LENTINI</b>	<b>MALPRACTICE</b> Provides relative to notification of medical review panels.
<b>SB 212</b>	<b>MARIONNEAUX</b>	<b>CIVIL PROCEDURE</b> Requires a filing fee to be paid by the party praying for a jury in a civil trial.
<b>SB 247</b>	<b>MOUNT</b>	<b>CONTRACTS</b> Provides for the retroactive effect of a partnership's or a limited liability company's existence when immovable property is acquired prior to their creation. (gov sig)
<b>SB 251</b>	<b>MALONE</b>	<b>MINERALS</b> Provides relative to certain unsolicited offers for lease or purchase of mineral rights.
