| HCR 22 | JEFFERSON | VOTING/REGISTRATION Directs the Louisiana Dept. of Public Safety and Corrections to create a system to notify those convicted of a felony who have completed their terms of confinement or parole relative to reinstatement of voter registration |
| HCR 29 | BADON | SALES/TOBACCO TRADE Relative to the sale of tobacco in certain quantities |
| HB 7 | GUILLORY, M. | COURTS/CITY Increases the jurisdictional amount of the City Court of Eunice |
| HB 18 | SMITH, JOHN | COURTS/COURT REPORTERS Provides for court reporter fees in the 36 th JDC |
| HB 95 | SMITH, GARY | MILITARY AFFAIRS/NATL GD Provides for reimbursement of members of LANG for premiums paid for life insurance |
| HB 116 | FARRAR | LOCAL OFFL/MARSHALS Prohibits the marshal of the Pineville City Court from collecting a fee or mileage allowance for attempted service of process |
| HB 166 | MCDONALD | COURTS/JUSTICE OF PEACE Provides that the election districts for the justice of the peace courts in West Carroll Parish shall coincide with parish police jury districts |
| HB 168 | ANSARDI | COURTS/TRIAL Assesses civil and criminal fees for the operation of the Lengthy Trial Fund |
| HB 198 | THOMPSON | SHERIFFS Provides for the payment of insurance premiums for certain retired sheriffs and deputy sheriffs in Richland Parish |
| HB 295 | TOWNSEND | COURTS/COURT REPORTERS Provides for court reporter fees in the 39 th JDC |
| HB 306 | CAZAYOUX | COURTS/CITY Provides for the imposition of fees in the City Court of Port Allen to fund indigent defense |
| HB 338 | POWELL, M. | ALCOHOLIC BEVERAGES Provides for limitations on the location of licensed liquor establishments |
| HB 351 | TRICHE | ALCOHOLIC BEVERAGE PERMT Provides that a duplicate driver's license shall be lawful identification for purposes of purchasing alcoholic beverages |
| HB 629 | HEBERT | TAX/TOBACCO TAX Provides relative to regulation of the sale of tobacco products |
| HB 711 | MORRELL | LAW ENFORCE/OFFICERS Provides relative to information retained in the personnel files of police officers |

HB 755	DARTEZ	ALCOHOLIC BEVERAGES Provides for a toll-free hotline for alcohol abuse
SB 115	MARIONNEAUX	COURTS Provides for the imposition of fees in the City Court of Port Allen to fund indigent defense.
SB 232	MURRAY	ALCOHOLIC BEVERAGES Creates and provides for a "museum" alcohol beverage permit that authorizes the sale of certain commemorative bottles and the service of limited product samples in a historic museum facility operated in a historic preservation district.
