| HB 10 | FRITH | DISTRICTS/SPECIAL Provides with respect to the membership of the board of commissioners of Beachfront Development District No. Two of Cameron Parish |
| HB 249 | FRITH | PLANNING/ZONING Authorizes the Cameron Parish governing authority to provide for the siting of facilities for disposal, incineration, or storage of solid or liquid waste in the parish and provides relative to regulation of such waste in the parish |
| HB 309 | FRITH | TAX/HOTEL OCCUPANCY Authorizes the Vermilion Parish Tourist Commission to increase the hotel occupancy tax and to provide for youth programs and dedicates the proceeds of the tax increase to youth programs |
| HB 310 | LAFLEUR | DISTRICTS/RECREATION Provides with respect to the Evangeline-Ville Platte Recreation District board of commissioners |
| HB 379 | HUTTER | DISTRICTS/SPECIAL Creates the St. Bernard Parish Arts, Culture, and Entertainment District |
| HB 493 | FARRAR | OFFICIAL JOURNALS Provides relative to the official journal of Rapides Parish and its political subdivisions, including provisions pertaining to the publication of proceedings, financial statements, and judicial advertisements and other legal notices |
| HB 563 | GRAY | FIRE PROTECT/FIRE DEPTS Requires the fire department of the city of New Orleans to adopt a written policy establishing a maximum age requirement for any person hired as a fire suppression employee of such department |
| HB 605 | RICHMOND | DISTRICTS/HISTORIC Provides relative to constitutionally created historic preservation district commissions |
| HB 652 | WRIGHT | OFFICIAL JOURNALS Authorizes the governing authority of any parish with a population below sixteen thousand and any political subdivision within such parish to establish and maintain an official website as the official journal of the parish or political subdivision |
| HB 757 | DAMICO | LOCAL EMPLOYEES Provides relative to sick leave benefits for firemen employed by a municipality, parish, or fire protection district |

HB 820	DOVE	DISTRICTS/ECONOMIC DEVEL Provides relative to the board of commissioners, budget, financial reports, and powers of the Terrebonne Economic Development Authority
HB 826	ERDEY	TAX/LOCAL Authorizes the Livingston Parish governing authority to levy a documentary transaction tax or immovable property transaction fee
HB 853	HUTTER	DISTRICTS/REDEVELOPMENT Creates St. Bernard Parish Housing, Redevelopment, and Quality of Life Commission
HB 870	GRAY	DISTRICTS/SPECIAL Creates the Orleans Parish Juvenile Services Financing District
HCR 18	FAUCHEUX	PARKS/STATE Requests the office of state parks in coordination with the Louisiana Department of Wildlife and Fisheries to study the suitability of establishing a state park in the Maurepas Swamp Wildlife Management Area
