| HB 158 | MARCHAND | EDUCATION Relative to compulsory k-12 school attendance, authorizes La. licensed nurse practitioners to substantiate certain illnesses permitting temporary absence and removes exemptions based on child's residence |
| HB 178 | HUTTER | SCHOOLS/EMPLOYEES Prohibits, except under certain circumstances, public and private school systems from hiring persons convicted of certain crimes or permitting such persons to provide any services on school property for contractors and others performing work or providing goods or services |
| HB 619 | SALTER | STUDENT/TUITION Authorizes postsecondary education management boards to increase tuition and mandatory attendance fees consistent with certain policies of the Board of Regents |
| HB 429 | HONEY | SCHOOLS/LOCAL SUPERINTDT Provides prospectively relative to the employment and removal of a superintendent of schools by a city, parish, or other local public school board |
| HB 514 | BADON | TEXTBOOKS/MATERIALS Provides for BESE rules requiring local school board policies relative to student use after regular school hours of certain textbooks; provides for accountability for such textbooks and for rules and policies |
| HB 651 | CARTER, K. | EDUCATION Requires persons attending certain schools to provide documentation relative to health insurance status annually and provides for release of such information to public health insurance programs that cover children |
| HB 184 | FRITH | PROPERTY/PUBLIC Provides for the transfer of certain sixteenth section land in Vermilion Parish |
| HB 314 | WALSWORTH | PUBLIC BLDGS/GROUNDS-ST Authorizes the Ouachita Parish School Board to name the ROTC building at West Monroe High School in honor of James Donald Halsell, Jr. |
| HB 377 | DOWNS | TAX/SALES-USE, LOCAL Authorizes the Union Parish School Board, subject to voter approval, to levy and collect an additional sales tax |
| HB 476 | JACKSON, M. | STUDENT/SCH ATTENDANCE Provides relative to the age at which children enter public school |
| HCR 75 | SHEPHERD (TBA) | STUDENT/ASSESSMENT Directs the state Dept. of Education to provide certain tests to parents upon request (Subject to Rule Suspension) |
