HB 305	HONEY	FIRE PROTECT/FIREMEN Provides for benefits for loss of hearing to those in classified fire service
HB 368	MARCHAND	MUNICIPALITIES/NO Authorizes the governing authority of the city of New Orleans to use photographic equipment for enforcement of certain traffic violations
HB 417	MARTINY	TAX/SALES-USE, LOCAL Increases amount of sales and use tax that can be levied in New Orleans International Airport Sales Tax District by the Kenner city council acting as the district governing authority
HB 480	ARNOLD	ASSESSORS Provides with respect to funding for the Board of Assessors for Orleans Parish
HB 481	ARNOLD	ASSESSORS Creates funding for the Board of Assessors for Orleans Parish
HB 598	LAFONTA	DISTRICTS/HISTORIC Provides for procedures for approval of applications for certificates of appropriateness for certain new construction in certain historic preservation districts

HB 640	LAFONTA	TAX/AD VALOREM TAX Authorizes the city of New Orleans to impose upon certain governing authorities a fee to defray cost of collecting ad valorem taxes
HB 760	BADON	FIRE PROTECT/FIREMEN Relative to loss of hearing during employment and classified fire service
HB 822	SHEPHERD	GAMBLING/RIVERBOAT Provides relative to the allocation of riverboat boarding fees in Jefferson Parish
