| <b>HR 99</b>   | <b>WALKER (TBA)</b>  | <b>STATE AGENCIES</b> Requests the House Committee on Municipal, Parochial and Cultural Affairs to study designating the Department of Culture, Recreation and Tourism as a charter agency as a pilot program to determine the effectiveness and benefits of a charter agency program <b>(Subject to Rules Suspension)</b> |
| <b>HCR 281</b> | <b>HAMMETT (TBA)</b> | <b>LEGISLATIVE AGCY/LAW INST</b> Directs the Louisiana State Law Institute to study trespassing laws as they relate to professional land surveyors <b>(Subject to Rules Suspension)</b>  |
| <b>SCR 105</b> | <b>JONES</b>         | <b>SECRETARY OF STATE</b> Directs the secretary of state to assess the steps that need to be taken to provide for satellite voting on election day for displaced voters and to provide a report on the requirements to the legislature.  |
| <b>SCR 117</b> | <b>JONES (TBA)</b>   | <b>LEGIS POWERS/FUNCTIONS</b> Creates the Louisiana Sentencing Practices Commission to study the current and history of sentencing practices of the state and to make recommendations to the legislature before the 2007 Regular Session. <b>(Subject to Rules Suspension)</b>   |
| <b>SCR 121</b> | <b>HINES (TBA)</b>   | <b>JOINT RULES</b> Provides for the interpretation and implementation of Article III, Section 2(A)(4)(b) of the Constitution of Louisiana. <b>(Subject to Rules Suspension)</b>  |
| <b>SB 597</b>  | <b>DARDENNE</b>      | <b>SECRETARY OF STATE</b> Provides means to shield address of registered voters who are victims of abuse.  |
