| HB 467 | WALSWORTH | ECONOMIC DEVEL/COMMUNITY Creates the Bawcomville Economic Development District |
| HB 493 | WOOTON | DISTRICTS/SPECIAL Provides relative to the Plaquemines Parish Courthouse District |
| HB 543 | HEBERT | LOCAL FINANCE/BUDGET ACT Requires parish and municipal governing authorities at the beginning of a term of office to study certain functions, programs, and services of the governmental entity relative to their effectiveness, efficiency, and responsiveness |
| HB 712 | WALSWORTH | SEIZURES/SALES Provides for the maximum amount of the fee or commission a realtor may receive for assisting local governments in selling tax-adjudicated property and authorizes negotiated fees |
| HB 741 | RICHMOND | PUBLIC WORKS Establishes a local hiring preference in Orleans Parish for certain public works contracts |
| HB 751 | GRAY | PLANNING/ZONING (Constitutional Amendment) Requires land use and zoning regulations to include provisions for inclusionary zoning for affordable housing |
| HB 762 | WINSTON | MUNICIPAL Authorizes the governing authority of the village of Folsom, subject to voter approval, to impose impact fees on new development |
| HB 881 | QUEZAIRE | PROCUREMENT Provides relative to telecommunications and procurement by political subdivisions |
| HB 974 | GRAY | PLANNING/ZONING Authorizes and requires municipalities and parishes with land use or zoning ordinances or regulations to provide for inclusionary zoning for affordable housing |
| HB 1091 | JACKSON, M. | PARISHES Relative to parish redevelopment agencies, provides for effectiveness of provisions applicable thereto in parishes with a population exceeding 400,000 by ordinance instead of election |
| HB 1160 | FAUCHEUX | PLANNING/ZONING Authorizes the governing authority of certain municipalities to pay a per diem to members of the municipal planning commission |

HB 1183 MORRISH

PARISH/GOVERN AUTHORITY Authorizes parish governing authorities to provide for the general health, safety, and welfare of the citizens of their respective parishes

HB 1259 BURRELL

PROPERTY Provides relative to property adjudicated to a parish or municipality for the nonpayment of taxes or other charges and assessments

HB 1333 CRAVINS

DISTRICTS/SPECIAL Provides with respect to the St. Landry Parish public works districts

HCR 128 DURAND

TOURISM Creates and provides for the Central Acadiana Tourism Development Advisory Commission to study and make recommendations relative to regional tourism development
