| SB 235 | SMITH, MIKE (TBA) | EMPLOYMENT Permits hospital service districts with a population of 100,000 or less and hospital public trust authorities to enter into initial recruiting contracts with a health care provider when such person is a member of the immediate family of any district board or authority member or the chief |

- SCR 67 BROOME ECONOMIC DEVELOPMENT** Establishes the Task Force on Poverty.
- SCR 26 SHEPHERD ETHICS** Directs the Board of Ethics staff to cease and desist all lobbying efforts at the legislature as provided for by law.
- SCR 33 MALONE PARDONS** Expresses legislative intent for meaning of Act 1492 of the 1997 Regular Session relative to pardons and the right to qualify for office and hold office.
- SCR 39 JONES LEGIS POWERS/FUNCTIONS** Requests the president of the Senate and the speaker of the House of Representatives to permanently display a photograph of Coach Eddie Robinson in Memorial Hall at the state capitol.
- SCR 58 MOUNT DOMESTIC VIOLENCE** Creates the Louisiana Task Force on Domestic Violence.
- SCR 64 JONES VOTERS/VOTING** Requests every mayor, sheriff and chief of police in the state of Louisiana to make available the opportunity for every person who is incarcerated, but not convicted of a crime, the right to vote absentee in the fall 2007 elections.
