<b>HB 192</b>	<b>ALARIO</b>	<b>TAX INCREMENT FINANCING</b> Repeals the authorization for sales tax increment financing for Jefferson Parish
<b>HB 199</b>	<b>CAZAYOUX</b>	<b>LIBRARIES</b> Provides relative to the use of certain donations received by the West Baton Rouge Parish Library
<b>HB 264</b>	<b>MCVEA</b>	<b>PLANNING/ZONING</b> Provides relative to zoning in East Feliciana Parish
<b>HB 292</b>	<b>LAFLEUR</b>	<b>TOURISM/COMMISSION</b> Increases maximum rate of hotel occupancy tax authorized to be levied by the St. Landry Parish Tourist Commission
<b>HB 332</b>	<b>CHANDLER</b>	<b>DISTRICTS/ECONOMIC DEVEL</b> Creates the Olla, Urania, Tullos, Standard Economic and Industrial Development District in LaSalle Parish
<b>HB 333</b>	<b>CHANDLER</b>	<b>DISTRICTS/ECONOMIC DEVEL</b> Provides relative to the board of commissioners of the Grant Parish Economic Development District
<b>HB 334</b>	<b>CHANDLER</b>	<b>DISTRICTS/ECONOMIC DEVEL</b> Creates the Pollock Economic and Industrial Development District
<b>HB 343</b>	<b>POWELL, M.</b>	<b>DISTRICTS/FIRE PROTECT</b> Provides relative to the composition of the board of commissioners of Caddo Parish Fire District Number Five
<b>HB 477</b>	<b>TRICHE</b>	<b>MUSEUMS</b> Provides relative to membership of the Board of Directors of the Louisiana State Museum
<b>HB 526</b>	<b>ANDERS</b>	<b>TAX/HOTEL OCCUPANCY</b> Relative to the Vidalia Riverfront Development District and its governing authority, provides that the district shall be a political subdivision of the state and authorizes it to levy a hotel occupancy tax the proceeds thereof to be used for a convention center in Vidalia
<b>HB 566</b>	<b>BURRELL</b>	<b>MUSEUMS</b> Changes the name of the McNeill Street Pumping Station Museum to the Water Works Museum

<b>HB 607</b>	<b>ALARIO</b>	<b>LOCAL FINANCE</b> Authorizes Jefferson Parish to create a special district and to provide for its governance and powers
<b>HB 715</b>	<b>MCVEA</b>	<b>PARISH/WEST FELICIANA</b> Authorizes the governing authority of West Feliciana Parish to impose impact fees on new development
<b>HB 750</b>	<b>HONEY (TBA)</b>	<b>TOURISM/COMMISSION</b> Provides relative to the powers and duties of the Baton Rouge Area Convention and Visitors Bureau ( <b>Subject to Rule Suspension</b> )
<b>HB 771</b>	<b>JEFFERSON</b>	<b>DISTRICTS/CRIME PREVENT</b> Provides relative to a parcel fee imposed within the Twinbrook Security District in Orleans Parish
<b>HB 794</b>	<b>SALTER</b>	<b>FUNDS/INVESTMENTS</b> Provides that investments in Louisiana Business and Industrial Development Companies are legal investments
