HB 113	POWELL, M. (TBA)	CRIME/THEFT Creates the crime of organized retail theft (Subject to Rule Suspension)
HB 197	TOOMY	GAMBLING/REVENUES Provides with respect to the allocation of the portion of the riverboat admission fee levied by Jefferson Parish
HB 222	JOHNS (TBA)	CORRECTIONS Amends prison enterprise provisions regarding the sale of products and services (Subject to Rule Suspension)
HB 238	WOOTON	GAMBLING Increases the amount of business a supplier of non-gaming goods and services must conduct for issuance of a non-gaming supplier permit
HB 288	ODINET	CRIMINAL/BUREAU CRIML ID Provides for assessment of fees for Acadiana Criminalistics Laboratory
HB 294	CHANDLER	JUVENILES/DETENTION FAC Changes name of Central Louisiana Juvenile Detention Center Authority and removes requirement that meetings of the board of commissioners be held at board domicile
HB 301	HUTTER	CONTRACTORS Provides for changes to the contractor's licensing law
HB 390	DEWITT	GAMBLING/VIDEO POKER Provides for the location of truck stop facilities after January 1, 2008
HB 460	GUILLORY, MICKEY	ELDERLY Increases mandatory imprisonment when crime of identity theft involves elderly or disabled victims
HB 510	WHITE	CRIMINAL/RECORDS Requires inclusion of name, date of birth, state identification number, arrest tracking number, and date of offense to be transmitted by certain law enforcement agencies on criminal records
HB 519	GUILLORY, ELCIE	CRIME/BATTERY Amends the crime of domestic abuse battery

HB 613	DORSEY (TBA)	GAMBLING/RIVERBOAT Authorizes East Baton Rouge Parish local governing authority to levy riverboat boarding fees (Subject to Rule Suspension)
HB 614	BEARD	ABORTION Provides with respect to partial birth abortion
HB 645	GUILLORY, ELBERT	CORRECTIONS Provides for a pilot program for drug counseling for certain offenders
HB 681	GRAY	JUVENILE PROCEDURE Provides for eligibility for parole of certain juvenile offenders
HB 756	DEWITT	GAMBLING/VIDEO POKER Amends provisions of law regarding fuel sales requirements and the location of qualified truck stops licensed to operate video draw poker devices licensed after certain date
HB 889	QUEZAIRE	GAMBLING/VIDEO POKER Repeals provision of law providing for good faith reliance on inaccurate survey
