<b>HB 54</b>	<b>GUILLORY, MICKEY</b>	<b>HOUSING/AUTHORITIES</b> Requires a local housing authority to enter into an employment contract with the executive director of the housing authority
<b>HB 157</b>	<b>CONNICK</b>	<b>CIVIL/PROCEDURE</b> Provides for proceedings on the 24th JDC Environmental docket
<b>HB 299</b>	<b>MORRELL</b>	<b>DISTRICTS/ECONOMIC DEVEL</b> Creates the Gentilly Development District in Orleans Parish
<b>HB 387</b>	<b>BILLIOT</b>	<b>CIVIL SERVICE/FIRE &amp; POL</b> Provides relative to the qualifications of members of the Jefferson Parish Fire Civil Service Board
<b>HB 401</b>	<b>MORRELL</b>	<b>DISTRICTS/TAXING</b> Creates the Gentilly Taxing District in Orleans Parish
<b>HB 438</b>	<b>LIGI</b>	<b>PUBLIC EMPLOYEES</b> Provides relative to drug testing of employees of local governmental subdivisions
<b>HB 456</b>	<b>HONEY</b>	<b>LIABILITY/PUBLIC</b> (Constitutional Amendment) Provides relative to the seizure of property owned by political subdivisions of the state
<b>HB 465</b>	<b>LABRUZZO</b>	<b>DISTRICTS/TAXING</b> Authorizes Jefferson Parish to create a special district with tax increment financing authority
<b>HB 523</b>	<b>CONNICK</b>	<b>PARISH/JEFFERSON</b> Authorizes Jefferson Parish to take certain actions in court relative to certain owners of deleterious premises
<b>HB 665</b>	<b>MILLS</b>	<b>TAX/SALES-USE, LOCAL</b> Authorizes municipal governing authorities to create sales tax districts with the power to levy an additional 1% local sales and use tax
<b>HB 733</b>	<b>SCHRODER</b>	<b>ENVIRONMENT/LITTERING</b> Provides with respect to the authority of parish governments to enforce litter abatement ordinances

<b>HB 745</b>	<b>FRANKLIN</b>	<b>DISTRICTS/ECONOMIC DEVEL</b> Creates the District Thirty-Four Economic Development District in Calcasieu Parish
<b>HB 792</b>	<b>WHITE</b>	<b>DISTRICTS/RECREATION</b> Provides for the creation of a recreation district in the city of Central
<b>HB 905</b>	<b>TUCKER</b>	<b>DISTRICTS/SPECIAL</b> Provides that certain members of community development district boards shall be appointed rather than elected
<b>HB 931</b>	<b>GEYMANN (TBA)</b>	<b>DISTRICTS/SPECIAL</b> Provides relative to the Calcasieu Parish Gaming Revenue District ( <b>Subject to Rule Suspension</b> )
<b>HB 970</b>	<b>HONEY</b>	<b>CIVIL SERVICE/FIRE &amp; POL</b> Provides relative to holiday compensation of firemen and policeman employed by certain municipalities
<b>HB 1093</b>	<b>CONNICK</b>	<b>PARISH/GOVERN AUTHORITY</b> Authorizes a parish governing authority to place certain charges of property owners on the ad valorem tax rolls of the parish
<b>HB 1094</b>	<b>DIXON</b>	<b>DISTRICTS/TAXING</b> Provides for the creation of a tax increment financing district in the city of Alexandria
