HB 88	BALDONE	ETHICS Requires the Board of Ethics to create a toll-free hotline and electronic mail address for the receipt of complaints made by state employees and to establish procedures for maintaining the anonymity and confidentiality of the complainant
HR 1	TUCKER	HOUSE/RULES Requires legislative proceedings occurring in the House Chamber or House committee rooms to be broadcast live via the Internet and to be maintained for at least three years
HR 2	TUCKER	HOUSE/RULES Provides for information required for appropriations to certain nongovernmental entities
HR 3	TUCKER	HOUSE/RULES Provides relative to a member seeking consent to correct his vote
HR 4	TUCKER	HOUSE/RULES Requires a request for legislation which is to be prefiled to be received by HLS staff not later than 48 hours prior to the prefiling deadline
HR 5	TUCKER	HOUSE/RULES Provides for the removal of an elected member of the Committee on Appropriations if such member is under indictment
HR 6	LABRUZZO	HOUSE/RULES Requires a person testifying before a committee to file a sworn written statement beforehand affirming the truth and correctness of his testimony
HR 7	MILLS	HOUSE/RULES Requires disclosure of certain information by persons testifying before House committees
HR 9	HINES	HOUSE/RULES Provides for and requires all registered lobbyists to wear lobbyist identification badges
HR 11	RICHMOND	HOUSE/RULES Requires a person testifying before a committee to file a sworn written statement beforehand affirming the truth and correctness of his testimony
HR 16	LABRUZZO	HOUSE/RULES Discontinues the daily distribution of the paper copies of the journal and order of the day to the members

SCR 5	CHAISSON	COURTS Urges and requests the Louisiana Supreme Court to adopt the same financial disclosure standards for judges that are applicable to other elected officials in the Code of Governmental Ethics.
HB 4	TUCKER	ETHICS/BOARD Provides relative to documentation and records of the Board of Ethics (Item #4(13))
HB 5	TUCKER	ETHICS Provides for the collection of fines, fees, and penalties assessed pursuant to laws within the jurisdiction of the Board of Ethics (Item #4(12))
HB 93	MORRELL	ETHICS/BOARD Provides relative to discovery of information obtained pursuant to private investigations conducted by the Board of Ethics (Item #4(1))
SB 34	KOSTELKA	CAMPAIGN FINANCE Prohibits candidates for elected office from using campaign contributions to pay family members. (gov sig)
HB 95	HINES	CAMPAIGN FINANCE Requires political advertisements paid for by a person other than a candidate or his principal or subsidiary committee to include a statement identifying the person who paid for the advertisement and stating whether it was authorized by the candidate or his committee (Item #7(2))
SB 14	MARIONNEAUX	ELECTION CODE Requires names and certain other information on electioneering communications and certain visual, oral and written political announcements and advertisements. (1/1/10)
SB 29	MARIONNEAUX	CAMPAIGN FINANCE Requires the filing of campaign reports by qualified 26 U.S.C.A. §527 political organizations regarding all persons making contributions to the organization, the amount of such contributions, and the expenditures made by the organizations.
SB 47	ADLEY	CAMPAIGN FINANCE Provides for felony violations of election campaign finance law. (3/30/08)
SB 65	SCALISE	CAMPAIGN FINANCE Provides relative to campaign contributions. (gov sig)
SCR 2	MURRAY	IMMOVABLE PROPERTY Creates a special committee to study and develop recommendations for facilitating the ability of co-owners of inherited immovable property to make their titles merchantable.
