4. **L08-258 - Acadia Parish, Fire Protection District No. 2** - 7.08 mills tax, 10 years, 2009-2018, constructing, acquiring, improving, maintaining and operating fire protection facilities and equipment and paying the cost of obtaining water for fire protection purposes.

36. **L08-282 - Orleans Parish, City of New Orleans** - To amend section 9-401 of the Home Rule Charter of the City of New Orleans relative to the office of inspector general (OIG) to require the Council establish the Office of Inspector General (OIG) by ordinance; to provide for the investigative, audit and other functions of the OIG including an Independent Police Monitor, to provide for guaranteed annual funding for the OIG and Ethics Review Board; and to provide that the OIG may retain special counsel.
37. **L08-313 - Orleans Parish Law Enforcement District** - Not exceeding \$63,225,000 General Obligation Bonds, not exceeding 8%, not exceeding 20 years, constructing, improving, renovating and repairing jails and other facilities for the Criminal Sheriff, District Attorney, Clerk of Criminal District Court, Juvenile Court, Municipal and Traffic Court and New Orleans Forensic Center.
38. **L08-315 - St. Bernard Parish Council** - 2% Occupancy Tax, attracting conventions and tourists into the area of the jurisdiction of the Commission, including, but not limited to, advertising, promotion and publication of information.
39. **L08-283 - St. Helena Parish Police Jury** - 3.55 mills tax, 10 years, 2009-2018, acquire, improve, maintain, operate and support Parish Senior Citizens' Centers and to provide funding for Parish Senior Citizens' programs, services and facilities provided, or operated by, the St. Helena Parish Council on Aging.
40. **L08-262 - St. Landry Parish Council, Road District No. 1** - 10 mills tax, 10 years, 2008-2017, constructing, acquiring, improving, and operating the roads, bridges and related drainage facilities of the new District and further to acquire the assets of St. Landry Public Works District/Road Commission Nos. 4, 5 and 6 and St. Landry Road District Nos. 2, 3, 7, 8, 9 and 10 and all subdistricts of the foregoing and following the acquisition of assets, to provide for the respective obligations of the current districts in a manner to allow for a rededication and/or termination of the road tax millages being levied by the current districts.
