| HB 90 | DOERGE | RETIREMENT/TEACHERS Provides relative to the maximum reserves in the employee experience account of the Teachers' Retirement System of Louisiana for the granting of cost-of-living adjustments (COLAs) |
| HB 232 | DOERGE | RETIREMENT/FIREFIGHTERS Provides for the inclusion of certain deferred holiday pay in the definition of "earnable compensation" for members of the Firefighters' Retirement System |
| HB 226 | ARMES | RETIREMENT/TEACHERS Provides relative to the Teachers' Retirement System of Louisiana with respect to disability retirement rehires |
| HB 356 | GALLOT | RETIREMENT/SHERIFFS FUND Relative to the Sheriff's Pension and Relief Fund, provides relative to the recalculation of benefits and restoration of service credit for certain rehired retirees |
| HB 467 | RICHARD | RETIREMENT/STATE EMPS Provides for early retirement of LASERS members with actuarial reduction of benefits; requires abolition of positions vacated by early retirement and permits reestablishment and filling of such positions under limited circumstances |
| HB 525 | ARNOLD | RETIREMENT/LOCAL Provides for per diem for members of the board of trustees of the Harbor Police Retirement System (Port of New Orleans) |
| HB 526 | ARNOLD | RETIREMENT/LOCAL Provides for a change in the cost-of-living adjustment (COLA) formula for members of the Harbor Police Retirement System |
| HB 534 | ARNOLD | RETIREMENT/LOCAL Provides for the funding of administrative expenses for the Harbor Police Retirement System |
| HB 723 | ARNOLD | RETIREMENT/LOCAL Provides for changes to Title 11 for members of the Firefighters' Pension and Relief Fund in the city of New Orleans |

HB 964	ARNOLD	RETIREMENT/LOCAL Clarifies deferred retirement option plan (DROP) participation provisions for certain members of the Harbor Police Retirement System (Port of New Orleans)
HB 982	ARNOLD	RETIREMENT/LOCAL Provides that members of the Firefighters' Pension and Relief Fund in the city of New Orleans can retire with 25 years of service at any age
HB 993	ARNOLD	RETIREMENT/LOCAL Creates a varying schedule of accrual rates of the retirement benefits for members of the Firefighters' Pension and Relief Fund in the city of New Orleans
HB 994	ARNOLD	RETIREMENT/LOCAL Provides for the conversion of leave upon regular retirement or entry into DROP for members of the Harbor Police Retirement System (Port of New Orleans)
HB 1215	HILL	RETIREMENT/SCHOOL EMPS Relative to the Louisiana School Employees' Retirement System, provides for the reemployment of retired school employees
